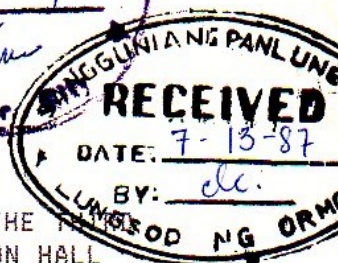

RESOLUTION NO. 238

"WHEREAS, considering the multifarious duties of the Honorable City Mayor not to mention the many problems which keep cropping up in the executive department;

"WHEREAS, the Honorable OIC City Mayor Emeterio V. Larrazabal has requested for the creation of the City Administrator under his office to help him in administering, governing, directing or supervising and implementing the affairs of all government transactions and undertakings;

"WHEREAS, it is but fitting and proper that the City of Ormoc should create this position because aside from being indispensable he acts as a caretaker for and in the absence of the City Executive;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, unanimously seconded by the august members of the Body;

"RESOLVED, to adopt:

ORDINANCE NO. 7

AN ORDINANCE CREATING THE POSITION OF CITY ADMINISTRATOR IN THE OFFICE OF THE CITY MAYOR WITH COMPENSATION AND THE RATE OF FIFTY-FIVE THOUSAND FOUR HUNDRED THIRTEEN PESOS & 60/100 (P55,413.60) PER ANNUM EFFECTIVE JULY 16, 1987.

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Creation of the Position of City Administrator. Office of the City Mayor. - The position of City Administrator in the Office of the City Mayor is hereby created with compensation at the rate of Fifty-Five Thousand Four Hundred Thirteen Pesos & 60/100 (P55,413.60) per annum, effective July 16, 1987; PROVIDED, HOWEVER, That fund for this

purpose shall be provided for in subsequent appropriation ordinances.


SECTION 2. Effectivity. - This Ordinance shall take effect July 16, 1987 subject, however, to the approval of the Joint Commission on Local Government Personnel Administration, Manila.



"CARRIED UNANIMOUSLY."


