RESOLUTION NO. 258

"WHEREAS, this august Body is in receipt of a Resolution No. 1, Series of 1987 of the Barangay Council of Bantigue, among others, earnestly requesting the August Members of the 3rd Sangguniang Panlungsod ng Ormoc to rename Barangay Bantigue Community School to Lorenzo Yrastorza Palou Community School in honor to the said virtuous and prominent citizen of Ormoc City, as raised by the residents of Barangay Bantigue;

"WHEREAS, portions of said resolution is quoted hereunder, to wit:

"WHEREAS, the residents of Barangay Bantigue recognize the role of the late Lorenzo Y. Palou in the establishment and development of Brgy. Bantigue considering the fact that he virtually owned almost all of the areas in which said barangay is situated;

"WHEREAS, due to his ambition and brilliant business acumen, his success as a farmer gave a better livelihood for the majority of the residents leaving a legacy of hope, enthusiasm and inspiration to the different generations of low-incomed inhabitants of this barangay;

"WHEREAS, the residents of Barangay Bantigue acknowledges the great support contributed by his children/heirs by their donation of sizeable portions of the lands owned by the late Lorenzo Y. Palou for barangay site, school site and chapel site;

"WHEREAS, the residents of our barangay find it reasonable and proper to express their gratitude and appreciation to this Honorable and virtuous citizen of Ormoc;

"WHEREAS, the late Lorenzo Y Palou was born on January 4, 1878 in Ormoc, Leyte (now Ormoc City). His parents were Ambrosio Palou and Maria Ursula Yrastorza. His first education was handed to him by his mother and later on he went to school and enrolled in the Ormoc Parochial School under the tutorship of the late Reverend Father Sergio Eamiguel. At the age of 37, he married Juana Pongos Y. Sabeno, that was on February 8, 1915. Their marriage begot eight (8) children; three (3) boys and five (5) girls, all of whom became prominent citizens in



our city and in our country. On December 29, 1931 he died at the age of 53 years. During his married life, he proved to be a loving father to his children encouraged by the gentleness and spiritual influence of his wife who became the backbone of the family in the later years after he died;

"WHEREAS, it is fitting and proper that this august Body should agree and confirm the said request in order to perpetuate the name of said virtuous and prominent citizen of Ormoc as raised by the residents of Barangay Bantigue;

"NOW, THEREFORE, on motion of Kagawad Fiel, jointly seconded by Mga Kagawad Subingsubing and Hermosilla; be it

"RESOLVED, to adopt:

ORDINANCE NO. 8

AN ORDINANCE RENAMING BARANGAY BANTIGUE COMMUNITY SCHOOL, ORMOC CITY, "LORENZO YRASTORZA PALOU COMMUNITY SCHOOL".

BE IT ORDAINED, BY THE Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Bantigue Community School in Barangay Bantigue, Ormoc City, is hereby renamed "Lorenzo Yrastorza Palou Community School".


SECTION. 2. This Ordinance shall take effect immediately upon its approval.

Palou, and all concerned, all in Ormoc City;
