RESOLUTION NO. 33

"WHEREAS, it has been noted with deep concern that washing of motor vehicles on the side of the city streets, on the shoulders thereon; and near at or around the vicinity of public artesian wells in the Poblacion of Ormoc City, is becoming rampant;

"WHEREAS, this practice cause traffic obstruction and pose as great danger to pedestrians and vehicles using the streets and the general public;

"WHEREAS, the approval of this measure will surely correct this undesirable act, at the same time enhance city cleanliness and sanitation;

"NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, jointly seconded by Mga Kagawad Eufrocino C. Codilla, Jr., and Arnulfo C. Salazar; be it

RESOLVED, to adopt:

ORDINANCE NO. 11

AN ORDINANCE PROHIBITING THE WASHING OF TRUCKS, BUSES, CARS, MOTORIZED TRICYCLES, MOTORCYCLES, TRACTORS, AND OTHER VEHICLES IN ALL ARTESIAN WELLS, CANALS AND OTHER WATER SOURCES, ON SHOULDERS OF CITY STREETS THEREOF, TO INCLUDE THE FOLLOWING BOUNDARIES; ON THE NORTH, FROM ORMOC MERIDA JUNCTION (ALONG LILIA AVENUE); ON THE WEST, AS FAR AS BARANGAY PUNTA; ON THE EAST, ALONG AGUA DULCE STREET AND ON THE SOUTHEAST, AS FAR AS BOUNDARY LIMITS OF BARANGAY CAMP DOWNES, ORMOC CITY, PROVIDING PENALTIES FOR VIOLATION THEREOF.

BE IT ORDAINED, by the Fifth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. - It shall be unlawful for any person or persons to wash motor vehicles such as: trucks, buses, cars, jeeps, motorized tricycles, motorcycles, tractors and other vehicles in any of the city streets, street shoulders, using water from canals, private water sources and near at or around the vicinity of public artesian wells in the Poblacion of Ormoc City, as well as along Lilia and R. Rivilla Avenues and as far as the boundary limits of Barangay Camp Downes and barangay roads from Alegria to Punta, Ormoc City;

SECTION 2. - Any violation of this Ordinance shall be punished by a fine of not more than Two Hundred Pesos (P200.00) or an imprisonment of not more than One (1) month or both at the discretion of the court;

SECTION 3. - Any and all existing ordinance in conflict with this Ordinance are deemed repealed.

SECTION 4. - If any part or parts of this Ordinance shall be declared unconstitutional or ultra-vires, said declaration shall not invalidate the whole of this Ordinance.

SECTION 5. - This Ordinance shall take effect immediately upon its approval.
