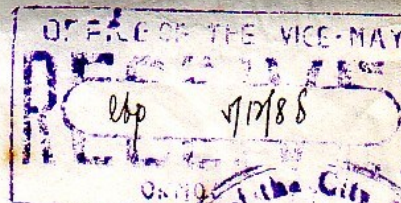

RESOLUTION NO. 39

"The Sangguniang Panlungsod ng Ormoc on motion of Kagawad Gregorio A. Yrastorza, Jr., seconded by Kagawad Arnulfo C. Salazar; be it

"RESOLVED, to adopt:

ORDINANCE NO. 12

AN ORDINANCE TO REGULATE THE USE OF VIDEO GAME COMPUTERS IN THE CITY OF ORMOC AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

SECTION 1. Definition of Term. - The term "Video Game Computer" shall be taken to mean the electronically operated machine which is hooked on a television set which when operated flashes out beams on its screen.

SECTION 2. Previous Permit and License Necessary. - Any person or operator who shall establish a Video Game Center shall first file an application to and secure a permit from the City Mayor and pay license tax and fee to the City Treasurer's Office in the amount of Seven Hundred Fifty Pesos (P750.00) for the first unit and Five Hundred Pesos (P500.00) for each succeeding units per annum.

SECTION 3. Hours and Days of Operation. - The game shall be played from 5:00 P.M. to 9:00 P.M. except on Saturdays, Sundays and holidays and during vacation time in which case the game may be played from 9:00 A.M. to 11:00 P.M. No center shall be established within a radius of One Hundred (100) meters from any school or church.

SECTION 4. Penalty. - Any person who violates any of the provisions hereof shall be punished by a fine of not less than Five Hundred Pesos (P500.00) but not more than One Thousand Pesos (P1,000.00) or an imprisonment of not less than one (1) month nor more than six (6) months or both at the discretion of the Court.

SECTION 5. Effectivity. - This Ordinance shall take effect immediately upon its approval.
