


RESOLUTION NO. 44

"WHEREAS, the then Third Sangguniang Panlungsod ng Ormoc passed Resolution No. 218, embodying Ordinance No. 8, dated May 10, 1987, adopting and implementing, among others, the organizational structure and staffing pattern in the local government of Ormoc as mandated in Section 145 (4) of the Local Government Code, otherwise, known as Batas Pambansa Blg. 337 and pursuant to MLG Circular No. 83-29 dated December 6, 1983 and as per recommendation of Honorable Resurreccion S. Salvatierra, DLE Assistant Regional Director, Regional Office No. VIII, Tacloban City;

"WHEREAS, the adoption and implementation of the organizational structure and staffing pattern in the local government of Ormoc was not pushed through because of the last local elections;

"WHEREAS, Her Honor, City Mayor Ma. Victoria L. Locsin has communicated to this august Body (Fifth Sangguniang Panlungsod) dated April 29, 1988, addressed to the Hon. Nepomuceno P. Aparis I, Vice-Mayor and Presiding Officer, quoted verbatim hereunder, thus:

Gentlemen:

One of the requirements for the planned orderly installation of the standard organizational structure and staffing patterns for local governments as promulgated by the Department of Local Government is the submission of the revised position classification and pay plan (PCPP) to the Joint Commission for review and approval.

Necessarily, the revised PCPP of Ormoc City has to be revised and approved by the Joint Commission in order to allocate properly the new positions in the standard structures and staffing patterns adopted by this city and to determine whether they are in conformity with the prescribed standards.

To avoid unnecessary delay in the review and approval of the revised PCPP of this city, the following documents are hereby submitted to this August Body for adoption thru a Resolution/Ordinance.:

1. Allocation (Placement) List
2. Organizational and Position Chart
3. List of Employees affected by the reorganization

"RESOLVED, to adopt:

ORDINANCE NO. 13

AN ORDINANCE ADOPTING THE ALLOCATION (PLACEMENT) LIST; ORGANIZATIONAL AND POSITION CHART; AND THE LIST OF EMPLOYEES AFFECTED BY THE REORGANIZATION AS EMBODIED IN THE REVISED POSITION CLASSIFICATION AND PAY PLAN (PCPP) OF ORMOC CITY.

BE IT ENACTED, by the Fifth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Adopting the Allocation (Placement) List; Organizational and Position Chart; and the List of Employees affected by the Reorganization. - The Allocation (Placement) List; Organizational and Position Chart; and the List of Employees affected by the Reorganization in the Local Government of Ormoc is hereby adopted as embodied in the Revised Position Classification and Pay Plan (PCPP) of Ormoc City.

SECTION 2. Effectivity. - This Ordinance shall take effect upon review and approval by the Honorable Joint Commission on Local Government Personnel Administration (JCLGPA).


