

The Sangguniang Panlungsod ng Ormoc on motion of Kagawad Rodolfo L. Rivilla, Jr., seconded by Kagawad Eufrocino C. Codilla, Jr.; be it

"RESOLVED, to adopt:

ORDINANCE NO. 14

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 11, SERIES OF 1988, OTHERWISE KNOWN AS "AN ORDINANCE PROHIBITING THE WASHING OF TRUCKS, BUSES, CARS, MOTORIZED TRICYCLES, MOTORCYCLES, TRACTORS, AND OTHER VEHICLES IN ALL ARTESIAN WELLS, CANALS AND OTHER WATER SOURCES, ON SHOULDERS OF CITY STREETS THEREOF, TO INCLUDE THE FOLLOWING BOUNDARIES; ON THE NORTH, FROM ORMOC MERIDA JUNCTION (ALONG LILIA AVENUE); ON THE WEST, AS FAR AS BARANGAY PUNTA; ON THE EAST, ALONG AGUA DULCE STREET AND ON THE SOUTHEAST, AS FAR AS BOUNDARY LIMITS OF BARANGAY CAMP DOWNES, ORMOC CITY, PROVIDING PENALTIES FOR VIOLATION THEREOF."

BE IT ORDAINED, by the Fifth Sangguniang Panlungsod ng Ormoc, in session assembled;

SECTION 1. Amendment. - Section 2 of Ordinance No. 11, is hereby amended to read as follows:

SEC. 2. - Any violation of this Ordinance shall be punished by: for the first offense, a fine of not less than fifty pesos (P50.00) but not more than one hundred pesos (P100.00); for the second offense, a fine of not less than one hundred pesos (P100.00) but not more than one hundred fifty pesos (P150.00); and for the third offense, a fine of not less than two hundred pesos (P200.00) but not more than three hundred fifty pesos (P350.00) and impounding of the vehicle, until such fine is paid."

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
