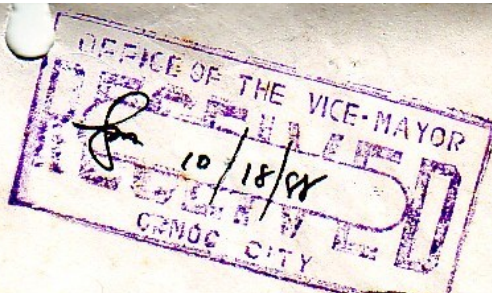
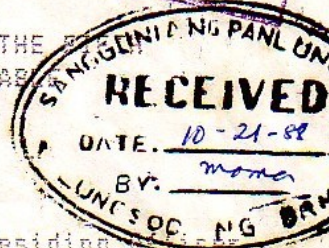

RESOLUTION NO. 109

WHEREAS, Section 3 of Article XI of the Constitution which, insofar as pertinent, declares that "no : x x barrio maybe x x x abolished x x x except in accordance with the criteria established in the local government code, and subject to the approval by a majority of the votes cast in the unit affected,";

WHEREAS, Section 6 of Rule II of the Implementing Rules of the Local Government Code provides that a barangay maybe abolished by Ordinance of the x x x Sangguniang Panglungsod of the x x x city in which it is located based upon a showing that the population, income and habitable land area of the local government unit concerned have been irreversibly reduced below the minimum standards prescribed for the creation of the local unit concerned and that it has not attained any significant improvement in the delivery of services in the preceding four (4) calendar years;

WHEREAS, Barangay Buenavista in Ormoc City for the past seven years up to now, has its substantial bulk of population transferred or relocated to relocation areas in Ormoc City thus greatly reducing its income below the prescribed minimum standard; and

WHEREAS, Barangay Buenavista's habitable land area has also been irreversibly reduced below the prescribed minimum standard for the said area is now made an extension of the government public plaza, rendering complete impossibility of attaining significant improvement in the delivery of services in the preceding four (4) calendar years;

NOW, THEREFORE, on motion of Kagawad Tugonon, jointly seconded by Mga Kagawad Arnulfo C. Salazar and Celso P. Porcadilla; be it

RESOLVED, to adopt:



ORDINANCE NO. 15

AN ORDINANCE ABOLISHING BARANGAY BUENAVISTA AS A LOCAL GOVERNMENT UNIT IN ORMOC CITY.

BE IT ORDAINED, by the Fifth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Abolition of Barangay Buenavista, Ormoc City. - Barangay Buenavista of Ormoc City is hereby abolished as a local government unit for its population, income and habitable areas as a local government unit it having irreversibly reduced below the prescribed minimum standards for its creation and that it has not attained any significant improvement in the delivery of services in the preceding four (4) calendar years;

SECTION 2. Merging the territorial jurisdiction and inhabitants therein. - The territorial jurisdiction and the remaining inhabitants of the abolished Barangay Buenavista is hereby merged to Barangay District No. XII of the poblacion area this city;

SECTION 3. Boundaries. - The boundaries of Barangay District XII are as follows: Bounded on the Northwest by Lopez Jaena St.; on the Northeast by San Pedro St.; on the Southeast by the Seashore; and on the Southwest by J. Navarro St.;

SECTION 4. Effectivity. - This Resolution-Ordinance shall take effect immediately upon its approval.

ENACTED, October 12, 1988.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Commission on Elections (COMELEC), Intramuros, Manila; Her Honor, the City Mayor, Ormoc City; the City Development Office, DLS, Ormoc City; the City Election Registrar, COMELEC Office, Ormoc City; and all Department Heads in Ormoc City, and three copies to be posted each on Bulletin Boards.

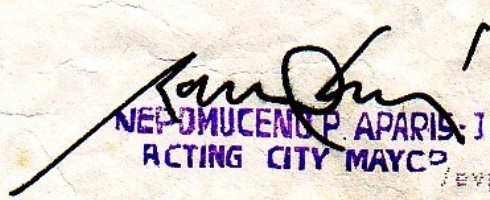
