**RESOLUTION NO. 166**

WHEREAS, in the public hearing of December 2, 1988 conducted by the Committee on Transportation and Communication, the motorized tricycle service operators agreed to follow the New Schedule of Rates prescribed and promulgated by the Fifth Sangguniang Panlungsod ng Ormoc whereby regular passengers are charged Seventy-Five (P0.75) centavos within the City Proper or within a distance of one kilometer or less and Fifty-Five (P0.55) centavos for students;

**ORDINANCE NO. 17**

AN ORDINANCE TO AUTHORIZE MOTORIZED TRICYCLE SERVICE OPERATORS TO ADOPT THE NEW SCHEDULE OF RATES PRESCRIBED AND PROMULGATED BY THE FIFTH SANGGUNIANG PANLUNGSOD NG ORMOC

BE IT ORDAINED, by the Fifth Sangguniang Panlungsod ng Ormoc, that:

**SECTION 1. New Rates Schedule.** - Motorized tricycle service operators are hereby authorized to adopt the new schedule of rates prescribed and promulgated by the Fifth Sangguniang Panlungsod ng Ormoc, as follows:

- Within the City Proper
- Slaughterhouse
- Alegria - Punta
- Linao
- Naungan

**SECTION 2. Definition of Term.** - For the purpose of this Ordinance by the term "within the City Proper" is meant to include:

- a) In the north - Cantubo Bridge and Madangholan Cockpit
- b) In the west - Ormoc City High School
- City Slaughterhouse and Livestock Market
- c) In the south - Can-adieng Bridge of Pardon
- d) In the east - Hermosilla Drive

**SECTION 3. Individual Application Requirement.** - Each operator or member of an association of motorized tricycle service operators is hereby required to file first his application to operate a motorized tricycle service with the Office of the Mayor before he can avail himself of the new rates prescribed in Section 1 hereof.

**SECTION 4.** All tricycle operators are hereby required to post these new approved rates on the windshield of each and every tricycle unit for the information of the general riding public.

**SECTION 5. Penalty Clause.** - Any violation of any of the provision of this Ordinance shall be imposed upon the operator and drivers a penalty of suspension of operation of ten (10) days for first offense; twenty (20) days for second offense; and revocation of "City Mayor's Permit" for third offense;

**SECTION 6. Effectivity.** - This Ordinance shall take effect immediately upon its approval.

ENACTED, December 22, 1988.
