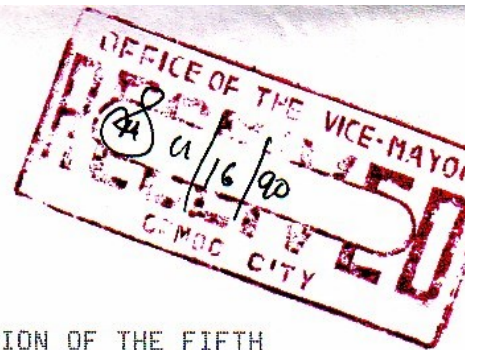

RESOLUTION NO. 142

WHEREAS, Ormoc City is indeed proud to have a man who served as a public servant with utmost dedication and unstained devotion to duty for so quite a long time;

WHEREAS, it is but fitting and proper that this model of a public official, found in the person of the late Honorable INAKI ABLEN LARRAZABAL, SR. be accorded a place in the history of Ormoc City and, be forever enshrined in the hearts and minds of his constituents - his fellow Ormocanons whom he loved and served;

WHEREAS, the late Honorable Mayor Inaki Ablen Larrazabal, Sr. has served Ormoc City in the following capacities:

March 4, 1948 to May 23, 1949, as appointed Mayor
June 1, 1953 to December 31, 1953, as appointed Mayor
January 1, 1952 to May 31, 1953 - Elected City Councilor
January 1 1956 to December 31, 1959 - Elected City Councilor
January 1, 1968 to December 30, 1986 - Elected City Mayor

WHEREAS, all these long years of steadfast devotion to duty and faithful dedication to service in the best interest of his constituents and to the progress of Ormoc City, should not be made to pass without expressing our deep appreciation for a job well done and a life well spent, all to the glory of the city he loved so much;

WHEREAS, it is needless to enumerate the achievements of the Honorable Mayor, whom we fondly called "Aki", for they are so numerous to mention. Suffice to say, Mayor "Aki" has to his credit lustrous records of public service, achievements in the political realm beyond compare. Also, we can only admire with great satisfaction his guts, courage and firm decisions, as he went along in the implementation of

ORDINANCE NO. 24

AN ORDINANCE RENAMING IMELDA AVENUE IN ORMOC CITY TO DON INAKI A. LARRAZABAL, SR. BOULEVARD.

BE IT ENACTED, by the Fifth Sangguniang Panlungsod ng Ormoc, That:"

SECTION 1. Renaming of Imelda Avenue. - Imelda Avenue which is located along Ormoc breakwater fronting the beautiful Ormoc Bay is hereby renamed "DON INAKI A. LARRAZABAL, SR. BOULEVARD".


SECTION 2. Effectivity. This ordinance shall take effect immediately upon its approval.

CARRIED UNANIMOUSLY.




