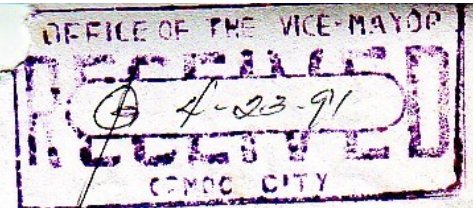

RESOLUTION NO. 43

WHEREAS, the Sangguniang Barangay ng Boroc, this city, through its Resolution No. 7 s. 1991, has requested the Fifth Sangguniang Panlungsod ng Ormoc for passage of AN ORDINANCE RENAMING BARANGAY BOROC TO BARANGAY DON CARLOS B. RIVILLA, SR., IN HONOR OF HIS EXEMPLARY CONTRIBUTIONS TO THE RESIDENTS OF THIS BARANGAY;

WHEREAS, the aforecited resolution has alleged the following:

- In many instances, progress and development of a barangay is closely associated with its name.
- While some barangays are so named so as to attract prospective investors and developers, Barangay Boroc has carved in itself a name that somehow has extended adverse connotations to most people in its vicinity.
- It is the desire of the present Barangay Council Officials to reshape the destiny of their barangay, to be at par with the rapid development of its neighbors, and
- They have unanimously chosen the name of the Late DON CARLOS B. RIVILLA, SR. to replace the name of Barangay Boroc, this city, as their token gesture to his unselfish contributions towards the upliftment of the lives of the people in their barangay.

WHEREAS, this august Body finds the request most worthy for consideration as a fitting tribute to a man who spent the best years of his life in service to humanity and his unselfish contributions towards the upliftment of the lives of the barangay residents of Boroc, hence imperative to preserve his name and honor that Barangay Boroc in the City of Ormoc be now renamed after him;

ORDINANCE NO.26

AN ORDINANCE RENAMING BARANGAY BOROC IN ORMOC CITY TO
BARANGAY DON CARLOS B. RIVILLA, SR.

BE IT ORDAINED, by the Fifth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Renaming of Barangay Boroc. Barangay Boroc in the City of Ormoc is hereby renamed "Barangay Don Carlos B. Rivilla, Sr."

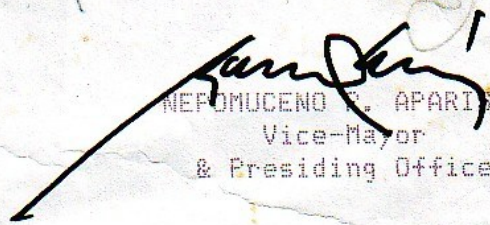
SECTION 2. Effectivity. This Ordinance shall take effect immediately upon its approval.

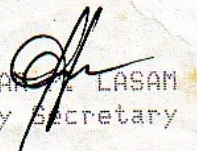

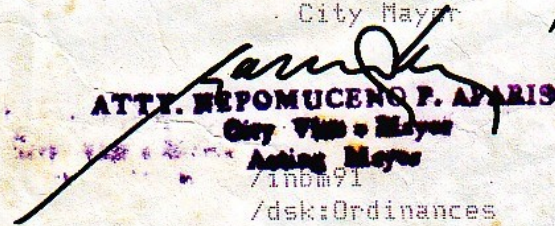
