ORDINANCE NO. 28

DINANCE TO AMEND SECTION 3, DISTRICT BOUNDARIES, ARTICLE ORDINANCE NO. 14, SERIES 1977, ENTITLED, "AN ORDINONCE AMENDING ORDINANCE NO. 9, SERIES 1977, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY OF OXMOC, AS AMENDED BY ORDINANCE NO. 22, SERIES 1990.

BE IT ENACTED, by the Fifth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment - Section 3, District Boundaries, Article IV of Ordinance No. 9, Series 1977, otherwise known as the "Comprehensive Zoning Ordinance of the City of Ormoc", as amended by Ordinance No. 22, Series 1990, is hereby amended to read as follows:

TECHNICAL DESCRIPTION

(Reclassifying Open Space Block V to

(Residential II Block VI)

A parcel of land known as (Residential II Block VI) situated in the Barangays Linao and Cogon, Ormoc Cadastre No. 254, Ormoc City, Bounded, on the N; along line 2-3, by Residential II, on the SE, along line 3-1,

by Institutional I, on the SW; along line 1-2, by Industrial I. Beginning from point (11) of Industrial I, marked on plan as point (1);

"Thence following Calamansi Street more or less 365 cm. West, marked on plan as point (2); thence following Caimito and Don Felipe Larrazabal-Punta road more or less 505 cm. East marked on plan as point (3); thence following Tugas Street more or less 260 cm. West marked on plan as point lof the beginning, containing an area of SIX (6) HECTARES".

SECTION 2. Effectivity. This Ordinance shall take effect immediately upon its approval.
