RESOLUTION NO. 100

WHEREAS, Executive Order No. 507 directs Local Government Units to revise their Annual Budget for 1992 pursuant to the provisions of the Local Government Code of 1991 which authorizes the creation of the Mandatory Positions, one of which is the Office of the City Accountant which was created per SP Resolution No. 45 dated March 19, 1992;

WHEREAS, said office is now incorporated in the revised Plantilla of Personnel for 1992 placing all accounting positions and function in the Accounting Department including the Internal Control Division existing under the Office of the City Administrator;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Arnulfo C. Salazar, be it

RESOLVED, to adopt:

ORDINANCE NO. 31

AN ORDINANCE MERGING THE ACCOUNTING DIVISION WITH THE
INTERNAL CONTROL DIVISION INTO ONE OFFICE WHICH
HEREINAFTER SHALL BE CALLED THE ACCOUNTING DEPARTMENT.

BE IT ORDAINED, by the Fifth Sangguniang Panlungsod ng Ormoc,
That:

SECTION 1. TITLE - This Ordinance shall be known as "An Ordinance Merging the Accounting Division with the Internal Control Division into one office which hereinafter shall be called the ACCOUNTING DEPARTMENT.

SECTION 2. Effectivity. This Ordinance shall take effect immediately upon its approval.
