RESOLUTION NO. 124

WHEREAS, the City Government of Ormoc has considered the granting of Year-End Benefits to all its casual employees who have rendered 3 1/2 months of service from January 1, 1992 to October 31, 1992;

WHEREAS, Article 99 (a) (1) (viii) of the Rules and Regulations Implementing the Local Government Code of 1991 (RRILGC) enumerates the powers, duties and functions of the Sangguniang Panlungsod which among others states that it shall:

"Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from the City Funds and provide for expenditures necessary for the proper conduct of progress, projects, services, and activities of the City Government";

WHEREAS, the General Welfare Clause embodied in Sec. 16 of the Local Government Code provides:

"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers, necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, the Honorable City Mayor has certified this matter as urgent per his letter addressed to the Honorable Vice-Mayor, appearing on page 92-335 of the Agenda;

WHEREAS, Art. 107, paragraph (f) of the Rules and Regulations Implementing the Local Government Code of 1991, authorizes a measure to be considered for final voting immediately after debate or amendment during the second reading when certified as urgent by the local chief executive;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi duly seconded by Kagawad Celso P. Adolfo; be it

RESOLVED, to adopt:

ORDINANCE NO. 33

AN ORDINANCE GRANTING A YEAR-END BENEFIT EQUIVALENT TO ONE MONTH SALARY PLUS ONE THOUSAND CASH GIFT TO EMPLOYEES WHO HAVE RENDERED AT LEAST 3 1/2 MONTHS OF SERVICE FROM JANUARY 1, 1992 TO OCTOBER 31, 1992.

BE IT ORDAINED, by the Sixth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. COVERAGE. All employees of the City Government of Ormoc who have rendered at least three and one-half (3 1/2) months of service from January 1, 1992 to October 31, 1992, and who were still in the service as of October 31, 1992, shall be entitled to a year end benefit equivalent to one (1) month basic salary and a cash gift of One Thousand (P1,000.00) Pesos.

SECTION 2. Authority to Disburse - That the City Treasurer is hereby authorized to disburse the herein benefits from out of the lump-sum appropriation per Appropriation Ordinance No. 92-23 series of 1992.

SECTION 3. Applicability - This Ordinance is applicable only for this particular year.

SECTION 4. Effectivity. This Ordinance shall take effect immediately upon its approval.

ENACTED, December 10, 1992.

RESOLVED, FINALLY, to furnish copies of this resolution-ordinance one each to His Honor, the City Mayor, the City Treasurer, the City Auditor and the City Budget Officer and sufficient copies thereof be posted on Bulletin Boards at conspicuous place, -all in Ormoc City;
