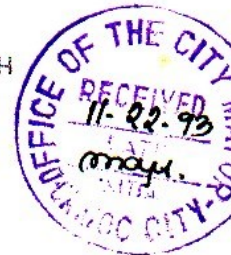

RESOLUTION NO. 203

A RESOLUTION TO PASS AN ORDINANCE DECLARING CERTAIN AREAS IN
ORMOC CITY AS HIGH RISK AND PROVIDING PENALTY FOR THE
VIOLATION THEREOF.

EXPLANATORY NOTE

It will be remembered that on November 5, 1991, a catastrophic flash flood brought about by typhoon "URING" hit Ormoc City, leaving in its wake unimaginable destruction both in lives and properties. Most of the victims and properties destroyed were living and located near the river banks and along the seashores. These are areas which are exposed to the natural elements, such as floods brought about by heavy down-pour, and by big waves brought about by strong winds. These are the areas denominated as "HIGH RISK".

To forestall the recurrence of such an unforgettable tragedy, it is the purpose of this Proposed Ordinance to prohibit the construction of buildings and other structures used for dwelling of people in those areas denominated as "HIGH RISK" to safeguard lives and properties, and so as not to impede the flow of water along the river banks. After all, the State through its agency which is the government is empowered under its "POLICE POWER" to promulgate rules that will promote the public welfare by restraining or regulating the use of liberty or property, under the time-honored principle of "Salus Populi Suprema Est Lex" which simply means that "The welfare of the people is the first law".

Likewise, the Local Government Code of 1991 (Republic Act 7160) under Section 458, paragraph (a) subparagraph (1) (iv), authorizes the Sangguniang Panlungsod to "Adopt measures to protect the inhabitants of the City from the harmful effects of man-made and natural disasters and calamities, X X X;"

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Benjamin B. Lladoc and Sotero M. Pepito; be it;

RESOLVED, to enact:

ORDINANCE NO. 37

AN ORDINANCE DECLARING CERTAIN AREAS IN ORMOC CITY AS HIGH RISK AND PROVIDING PENALTY FOR THE VIOLATION THEREOF.

The Sangguniang Panlungsod ng Ormoc, in regular session assembled, hereby ordains, that:

SECTION 1. This Ordinance hereby declares certain areas in Ormoc City as HIGH RISK.

SECTION 2. HIGH RISK AREA refers to identified areas which are considered as hazardous to life and property as they are exposed to the natural elements such as floods, landslides brought about by heavy down-pour, and by big waves brought about by strong winds.

SECTION 3. The following identified areas within the territorial jurisdiction of the City of Ormoc are hereby declared as HIGH RISK, to wit:

(A) ALEGRIA-PUNTA SHORELINE HIGH RISK AREA

SECTION 4. Notwithstanding the provisions of the next preceding section, the Sangguniang Panlungsod ng Ormoc reserves the right to declare other areas as HIGH RISK, as well as the right to revoke prior declaration of areas considered as HIGH RISK, when circumstances so warrant.

SECTION 5. It is the declared policy of the City Government of Ormoc that all areas which are declared as HIGH RISK to be hazardous to human life and/or property, hence human habitation, and the construction of any structure thereat are PROHIBITED.

SECTION 6. Owners of buildings or other structures which were already existing in areas now declared as HIGH RISK prior to the effectivity of this Ordinance are prohibited from repairing or remodelling the same, and are given three (3) years from the date thereof, within which to remove or demolish those buildings or

structures. Should the owners thereof fail to remove or demolish the same within the period provided herein, the City Government of Ormoc, at its option may undertake the removal or demolition of those buildings or structures at the expense of the owner or owners thereof: PROVIDED, that no removal or demolition shall be effected by the City Government of Ormoc unless prior written notice shall have been served to the owner/s thereof, and upon the expiration of at least fifteen (15) days from receipt of such notice; and PROVIDED, FINALLY, that the sanggunian may for humanitarian considerations extend the period of three (3) years within which existing buildings or structures in areas now declared as HIGH RISK will be removed or demolished.

SECTION 7. No building permit or license for the construction of any building or structure, or for the repairs or remodeling thereof within the areas declared as HIGH RISK shall be issued by the Office of the Building Official in the Office of the City Engineer of Ormoc.

SECTION 8. Any person violating the provisions of this Ordinance, upon conviction shall suffer the penalty of a fine not exceeding Five Thousand (P5,000.00) Pesos, or an imprisonment for a period not exceeding one (1) year, or both, at the discretion of the Court.

SECTION 9. Any ordinance or provision thereof inconsistent with any provisions of this Ordinance shall be deemed accordingly modified or repealed.

SECTION 10. If any section of this Ordinance is declared null and void, the other parts not so declared remain valid and enforceable.

SECTION 11. This Ordinance shall take effect after ten (10) days from the date a copy hereof is posted in a bulletin board at the entrance of the City Hall, and in at least two (2) other conspicuous places in the City of Ormoc.

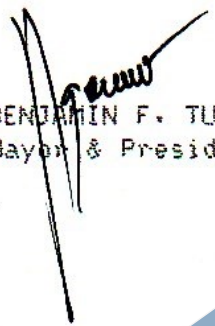
SECTION 12. For purposes of complying with the provisions of Section 511 of Republic Act 7160, otherwise known as the Local Government Code of 1991, a copy of this Ordinance shall be posted at prominent places in the City Hall for a minimum period of three (3) consecutive weeks.

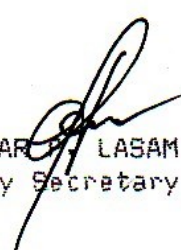

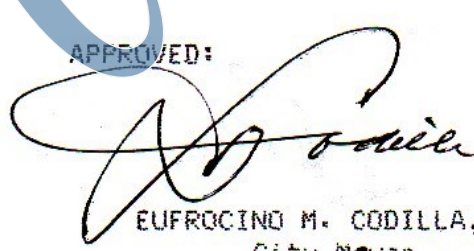
