RESOLUTION NO. 101

WHEREAS, this august Body on August 19, 1993, passed Tax Ordinance No. 93-05, entitled, "An Ordinance Revising the Schedule of Civil Registry Fees in Ormoc City";

WHEREAS, the President of the Philippines issued Proclamation No. 326, declaring it as a National State Policy to provide free of charge registration services for births, deaths and marriages;

WHEREAS, Civil Registrar General Tomas P. Africa per his letter of April 27, 1994 addressed to the City Secretary, Sangguniang Panlungsod ng Ormoc, expressed his doubt as to the propriety of the second paragraph, section three of Tax Ordinance No. 93-05 and requested that the same be deleted citing therein the opinion of the Secretary of Justice as basis;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Nestor C. Penserga and Kagawad Benjamin B. Liadoc; be it

RESOLVED, to enact:

ORDINANCE NO. 43

AN ORDINANCE TO AMEND TAX ORDINANCE NO. 93-05 ENTITLED, "AN ORDINANCE REVISING THE SCHEDULE OF CIVIL REGISTRY FEES IN ORMOC CITY" BY DELETING IN TOTO THE SECOND PARAGRAPH, SECTION THREE THEREOF.

BE IT ORDAINED by the Sangguniang Panlungsod ng Ormoc, in regular session assembled, that:

SECTION 1. That paragraph 2, Section 3 of Tax Ordinance No. 93-05 entitled, "An Ordinance Revising the Schedule of Civil Registry Fees in Ormoc City" which reads:

"However, if the registration of such births, marriages, deaths and foundling is done beyond the period prescribed above, the registration thereof shall be subject to the following fees: One Peso (₱1.00) for every year of delay or fraction thereof, plus Thirty Pesos (₱30.00) if the delay in the registration does not exceed ten (10) years; Fifty Pesos (₱50.00) if the delay in the registration exceeds ten (10) years but is not over twenty (20) years; and One Hundred Pesos (₱100.00) if the delay in the registration exceeds twenty (20) years." be deleted in toto.

SECTION 2. All the other provisions of Tax Ordinance 93-05 shall remain in full force and effect.

SECTION 3. This Ordinance shall take effect immediately upon its approval.

RESOLVED, FINALLY, to furnish copies of this Ordinance each to: Civil Registrar General Tomas P. Africa, National Statistics Office, Sta. Mesa, Metro Manila; the Honorable City Mayor Eufracio M. Codilla, Sr., the City Administrator, the City Legal Officer, the City Treasurer, the City Auditor, the City Civil Registrar, and others concerned, all in Ormoc City.
