RESOLUTION NO. 140

WHEREAS, in 1977 the Sangguniang Panlungsod ng Ormoc passed Ordinance No. 14, amending Ordinance No. 9, also Series of 1977, providing for the Comprehensive Zoning Plan for Ormoc City;

WHEREAS, the said Ordinance has set apart certain areas within the city as Parks and Open Space District in order to provide the public a pleasure ground for recreation to promote its health and enjoyment;

WHEREAS, in pursuit of the aforementioned objectives, the said Ordinance, specifically Sec. 12, Art. V thereof, prescribed the uses for the aforesaid district, as follows:

"SEC. 12. USE REGULATION FOR PARKS AND OPEN SPACE DISTRICT. - This district shall be mainly for parks and open spaces to provide ecological balance within the community and at the same time provide inexpensive recreation places for the inhabitants.

The following shall be allowable uses:

1. parks and playgrounds
2. zoo
3. botanical gardens
4. city plaza
5. memorial parks
6. other similar uses."

WHEREAS, certain sectors have misconstrued and/or misinterpreted the abovequoted provision as to prohibit the construction of all-weather cultural, sports and recreational facilities within the said district;

WHEREAS, in order to clarify, erase misconceptions, and make more meaningful the uses upon which Parks and Open Space District are to be devoted, and consistent with the purpose for which said district has been classified, there is an imperative need for the Sangguniang Panlungsod to supplement the aforementioned Section 12, Article V of Ordinance No. 9 s. 1977 as amended by Ordinance No. 14 series of 1977 (comprehensive zoning plan of Ormoc City);

WHEREAS, Section 12, Article VII of the aforementioned Ordinance grants to the Sangguniang Panlungsod, on its own motion, to amend, alter, supplement or repeal any provision of the same;

BE IT THEREFORE RESOLVED, as it is hereby resolved, to supplement Sec. 12, Art. V of Ordinance No. 9 s. 1977 as amended by Ordinance No. 14 s. 1977, as follows:

"SECTION 12. USE REGULATION FOR PARKS AND OPEN SPACE DISTRICT. - This district shall be mainly for parks and open space to provide ecological balance within the community and at the same time provide inexpensive recreation places for the inhabitants:

1. Parks and playgrounds
2. Zoo
3. Botanical gardens

6. Cultural center

WHEREFORE, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Urban Development, duly seconded by mga Kagawad Benjamin B. Llador and Fernando P. Parrilla; be it

RESOLVED, to adopt:

ORDINANCE NO. 45

AN ORDINANCE SUPPLEMENTING AND STRENGTHENING THE URBAN DEVELOPMENT PLAN OF ORMOC IN ACCORDANCE WITH THE OBJECTIVES AND PRIORITIES SET BY THE CITY DEVELOPMENT COUNCIL.

BE IT ORDAINED by the Sixth Sangguniang Panlungsod ng Ormoc, in regular session, That:

SECTION 1. Definition of Term: Supplement (or to supplement) means to add something to, or something added to giving additional explanation or information.

SECTION 2. Section 12, Article V of Ordinance No. 9 s. 1977 as amended by Ordinance No. 14 s. 1977 (Zoning Ordinance) shall therefore read as follows:

"SEC. 12. USE REGULATION FOR PARKS AND OPEN SPACE DISTRICT, (AS AMENDED). - This district shall be mainly for parks and open spaces to provide ecological balance within the community and at the same time provide inexpensive recreation places for the inhabitants.

The following shall be allowable uses:

1. Parks and grounds
2. Zoo
3. Botanical gardens
4. City Plaza
5. Memorial parks
6. Cultural center
7. Sports coliseum
8. Aviaries
9. Planetarium
10. Other similar uses."

SECTION 3. All Ordinances, resolutions, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby considered repealed and modified accordingly.

SECTION 4. Effectivity. This Ordinance shall take effect immediately upon its approval.

SECTION 5. For purposes of complying with the provision of Section 511 of Republic Act 7160, a copy of this Ordinance shall be posted at prominent places in the City Hall for a minimum of three (3) consecutive weeks.

ENACTED, August 19, 1994.

RESOLVED, FURTHER, to furnish copies of this Ordinance, one each, to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Treasurer, the City Budget, the City Auditor, the City Engineer, the City Assessor, the City Registrar Office, the City Health Office, the PNP-Ormoc Office, and other Offices concerned;

CARRIED by MAJORITY VOTES, with eight (8) affirmative votes, and three (3) negative votes registered by mga Kagawad Mariano Y. Corro, Sixto P. Pongos and Nestor C. Penserga.
