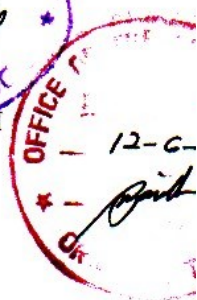
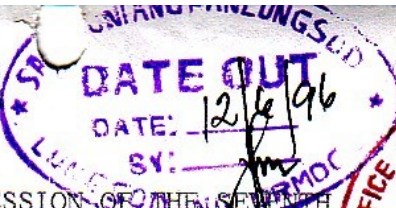
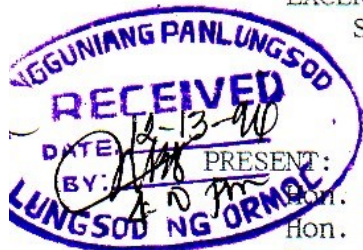

ORDINANCE NO. 96-56

AN ORDINANCE CREATING SIXTY NINE (69) NEW POSITIONS IN THE CITY GOVERNMENT OF ORMOC, AND APPROVING THEIR INTEGRATION INTO THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN THEREOF.

95 BE IT ENACTED, by the Seventh Sangguniang Panlungsod ng Ormoc,

96 That:

SECTION 1. There shall be created sixty nine (69) new positions in the different Offices of the City Government of Ormoc.


SECTION 3. Effectivity. This Ordinance shall take effect immediately upon its approval.

CARRIED UNANIMOUSLY.


