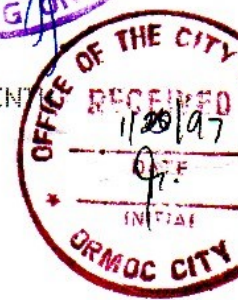
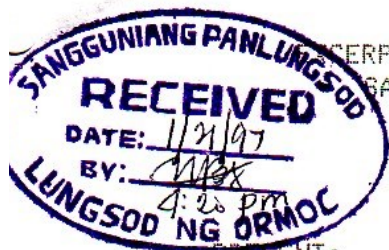
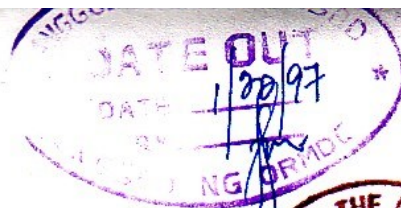

RESOLUTION NO. 97-09

EXPLANATORY NOTE

Last December 5, 1996, Ormoc City Motorcycle Operators & Drivers Association (OCMODA) filed a petition requesting for an increase in fare rates for tricycles.

The present fare for tricycle was approved last August 22, 1991. Since that time up to this date there had been several escalations in the price of fuel and other oil products so that the current fare does not anymore provide the operator a reasonable return.

After a public hearing with the operators, drivers and the commuting public, and after the result of the hearing was evaluated by the Committee on Transportation & Communications, the said Committee finds the petition of OCMODA to be meritorious and reasonable, and is recommending approval of the said petition.

WHEREFORE, on motion presented by Kagawad Mariano Y. Corro, Member, Committee on Transportation & Communications, severally seconded by mga Kagawad Sotero M. Pepito, Alfredo F. Capahi, Chiqui B. Labagala and Fernando P. Parrilla; be it

RESOLVED, to adopt:

ORDINANCE NO. 58

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 34 S. 1992, ENTITLED, "AN ORDINANCE ESTABLISHING, GUIDELINES, STANDARDS, RULES AND REGULATIONS, FOR THE OPERATIONS OF MOTORIZED TRICYCLES-FOR-HIRE AND THE ISSUANCE OF MOTORIZED TRICYCLE OPERATORS' PERMIT OR MTOP THEREBY IMPLEMENTING THE DEVOLUTION OF LTFRB'S FRANCHISING OVER TRICYCLES-FOR-HIRE TO THE CITY GOVERNMENT PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991 (R.A. NO. 7160)".

Be it ordained by the 7th Sangguniang Panlungsod ng Ormoc in Session assembled, that:

SECTION 1. Article III of Ordinance No. 34 is hereby amended to read as follows:

"Article III. Prescribed hereunder are the new fare-rates to be collected by operators of motorized tricycle operating within the City of Ormoc, to wit:

The foregoing schedule of fare rates should be posted prominently at the tricycle terminal, if any, and in a conspicuous part of the tricycle where said schedule can be easily seen by the passenger thereof. Failure to observe this requirement constitutes a violation of this Ordinance thereby making the operator and/or the driver of the tricycle liable to the penalty provided herein.

SECTION 2. Sections 1, 2 and 6 of Article V of Ordinance No. 34 are hereby amended by incorporating additional paragraphs to read as follows:

" Section 1. Requirement for new motorized tricycle operators' permit.

8. Three (3) copies of the Certificate of Cover evidencing the policy of insurance against both passenger and third party liability (TPL) for death or bodily injuries."

"Section 2. Renewal of Motorized Tricycle Operators' Permit.

X X X

4. Three (3) copies of the Certificate of Cover evidencing the policy of insurance against both passenger and third party liability (TPL) for death or bodily injuries.

"Section 6. Petition for increase of Equipment or units.

7. Three (3) copies of the Certificate of Cover evidencing the policy of insurance against both passenger and third party liability (TPL) for death or bodily injuries."

SECTION 3. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc.




