XPLANATORY NOTE

The enactment of this proposed Ordinance is anchored in the General Welfare provision of the Local Government Code of 1991 (RA 7160), particularly Section 16 thereof which empowers local government units to enact and implement measures for the general well-being of their Its basis is the police power of the State as delegated to local government units.

Specifically, this proposed Ordinance prohibits the flying of kites, the burning of any material in quantities that could affect the visibility in the flight path of the aircraft to the runways, within the premises of an airport and its surroundings within the territorial jurisdiction of Ormoc City, and the entering, loitering of unauthorized persons, vehicles and all kinds of animals within the airport and other prohibited designated areas thereof, as these apparently pose a hazard not only to such persons, vehicles and animals but more particularly for any aircraft and its occupants who use the airport.

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances and Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Transportation and Communications, seconded by mga Kagawad Claudio P. Larrazabal and Chiqui B. Labagala; be

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact;

ORDINANCE NO. 60

AN ORDINANCE PROHIBITING THE FLYING OF KITE OR KITES, THE BURNING OF MATERIALS IN QUANTITIES THAT COULD AFFECT THE VISIBILITY IN THE FLIGHT PATH OF THE AIRCRAFT TO THE RUNWAYS, WITHIN THE PREMISES AND SURROUNDINGS OF AIRPORT WITHIN THE TERRITORIAL JURISDICTION OF ORMOC CITY, AND THE ENTERING, LOITERING WITHIN THE SAME AREA BY PERSONS, VEHICLES AND ANIMALS OF ANY KIND, WITHOUT PROPER PERMISSION FROM THE MANAGEMENT/ADMINISTRATION OF SAID AIRPORT, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ORDAINED by the SEVENTH SANGGUNIANG PANLUNGSOD NG ORMOC in REGULAR SESSION assembled, That:

SECTION 1. No kite or kites shall be flown or caused to be flown within a radius of three (3) kilometers from an airport within the territorial jurisdiction of Ormoc City.

SECTION 2. Burning of any material or materials, especially dried palay stalks, in quantities that would produce so much smoke that would create a misty or foggy-like condition and thus cause poor visibility in the flight path of the aircraft to the runways, within a radius of 500 meters from an airport within Ormoc City is prohibited and declared unlawful.

SECTION 3. No person or persons, vehicle or vehicles, animal or animals of any kind, shall enter or loiter within the premises of an airport within the territorial jurisdiction of Ormoc City and other prohibited-designated area or areas thereof without the permission from the management/administration of said airport.

SECTION 4. Any person found guilty of violating the foregoing provisions shall suffer the penalty of fine not more than THREE THOUSAND (\$3,000.00) PESOS or imprisonment of not more than six (6) months, or both, at the discretion of the Court.

SECTION 5. For the purpose of this Ordinance, the penalty for the violation of Section 3 hereof shall be imposed upon the driver of the vehicle, and the person who allowed, permitted or caused the entry of the animal, including the owner of the vehicle and the animal when they were present at the time of the violation thereof.

SECTION 6. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. If, for any reason, any provision of this Ordinance is declared unconstitutional or unlawful, the other provisions hereof shall not be affected thereby.

SECTION 8. This Ordinance shall take effect on August 1, 1997, after its posting and publication in a local newspaper of general circulation.
