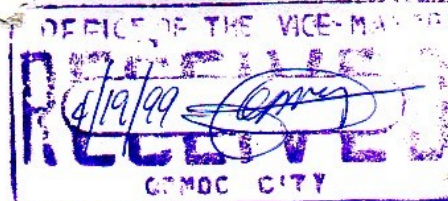

PREFATORY STATEMENT

One of the functions lodged in the Sangguniang Panlungsod by the Local Government Code of 1991, specifically, Section 458, par. (a) (2) (xiv) reads - "REGULATE THE NUMBERING OF RESIDENTIAL, COMMERCIAL AND OTHER BUILDINGS".

The existing Ordinances governing the numbering or renumbering of houses, buildings and other structure in the City of Ormoc, are Ordinance No. 2 which was enacted on October 19, 1976, yet, and Ordinance No. 35 which was enacted on April 13, 1982, fixing the selling price of house number plates at Six (P6.00) Pesos, each. These ordinances must be updated to attune to the needs of the times.

WHEREFORE, on motion of Councilor Mariano Y. Corro, Chairman, Committee on Ways and Means, duly seconded by Councilor Alfredo F. Capahi & Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

ORDINANCE NO. 69

AN ORDINANCE AMENDING CERTAIN SECTIONS OF ORDINANCE NO. 2, ENTITLED: "AN ORDINANCE TO NUMBER AND RENUMBER ALL HOUSES, BUILDINGS AND OTHER STRUCTURES AND THE LIKE IN THE POBLACION AND SUBURBS OF ORMOC CITY AT THE EXPENSE OF THE OWNERS OR DWELLERS THEREOF, PROVIDING PENALTIES FOR ITS VIOLATION" AND REPEALING ORDINANCE NO. 35, ENTITLED: "AN ORDINANCE TO FIX THE SELLING PRICE OF HOUSE NUMBER MADE OF METAL PLATES TO HOUSE OWNERS AT SIX PESOS (P6.00) EACH".

BE IT ORDAINED, by the 8TH SANGGUNIANG PANLUNGSOD ng ORMOC, in REGULAR SESSION assembled, That:

SECTION 1. An additional sections to Ordinance No. 2, are hereby adopted to read, as follows:

"Section 5A. After numbers shall have been assigned to all residential, commercial and other buildings in the manner specified in the next preceding section, number plates shall be installed thereto, with the following specifications:

- a) Material used, GA. 26 G.I. Sheet;
- b) Dimension, 3 1/2" x 6";
- c) Borderline and numbers must be in emboss print using brown acrylic paint and the rest (background) in yellow acrylic paint;
- d) Provide 3mm dia. hole for nails;
- e) All corners must be in curve cut for safety.

"Section 5B. The fabrication as well as the installation of the house/building number plates may be undertaken by the Office of the City Engineer of Ormoc, or by an Independent Contractor, at the discretion of the City Mayor in consultation with, and recommendation by the City Engineer of Ormoc;

"Section 5C. If the fabrication as well as the installation of the house/building number plates will be undertaken by an Independent Contractor, the City Mayor of Ormoc is hereby authorized to award the same to, and enter into a contract with, a qualified independent contract which shall be determined in accordance with existing laws, rules and regulations, and the cost thereof which will be charged to the house/building owners, including its installation, will be determined by the City Mayor in consultation with the City Engineer;

"Section 5D. The contract entered into by the City Mayor with Independent Contractor shall contain terms and conditions which shall protect the best interest of the City of Ormoc and the house/building owners, and shall include among others, the time frame within which to finish the project, and the issuance of an official receipt for the cost and installation of the house/building number plates to the house/building owner, and said contract shall be submitted to the Sangguniang Panlungsod for ratification.

"Section 6. Penalty for violation - Any house or building owner or dweller who fails or refuses to install a number plates for his or her house or building, as hereto provided, shall suffer the penalty of a fine not less than P100.00 nor more than P500.00 or imprisonment of not less than five (5) days nor more than fifteen (15) days at the discretion of the Court.

If the violator is a juridical person, the Manager or the one in charge of the building shall be held liable therefore."

SECTION 2. Ordinance No. 35, entitled: "AN ORDINANCE TO FIX THE SELLING PRICE OF HOUSE NUMBER MADE OF METAL PLATES TO HOUSE OWNERS AT SIX PESOS (P6.00) EACH" is hereby expressly repealed by this Ordinance, as the provisions thereof are no longer realistic.

SECTION 3. If for any reason any provision of this Ordinance is declared by any competent court, unconstitutional or invalid, other parts or provision thereof which are not affected thereby shall continue in full force and effect.

SECTION 4. All Ordinances and/or Resolutions, or portion thereof, inconsistent with this Ordinance are hereby repealed or modified accordingly.


SECTION 5. This Ordinance shall take effect on July 1, 1999, after it shall have been posted at conspicuous places in the City of Ormoc for at least three (3) consecutive weeks, and its publication in a local newspaper of general circulation.
