Last October 4, 1999 and October 15, 1999, Ormoc City Motorcycle Operators & Drivers Association (OCMODA) and Federation of Free Farmer's Drivers Association respectively, filed a petition requesting for an increase in fare rates for tricycles.

present here for tricycle was approved last January 16, ince that time up to this date there had been several escalations in price of fuel and other oil products so that the current fare does anymore provide the operator a reasonable return of investment.

fter a public hearing with the operators, drivers and the commuting public, and after the result of the hearing was evaluated by the Committee on Transportation & Communications, the said Committee finds the petition of OCMODA to be meritorious and reasonable, recommending approval of the said petition.

WHEREFORE, on motion presented by City Councilor Eduardo P. Jan, Chairman, Committee on Transportation & Communications, jointly seconded by City Councilors Sotero M. Pepito and Chiqui B. Labagala; be it

RESOLVED, to adopt:

ORDINANCE NO. 74

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 34 S. 1992, AS AMENDED, ENTITLED: "AN ORDINANCE ESTABLISHING GUIDELINES, STANDARDS, RULES AND REGULATIONS, FOR THE OPERATIONS OF MOTORIZED TRICYCLES-AND THE ISSUANCE OF MOTORIZED FOR-HIRE TRICYCLE PERMIT OR MTOP THEREBY IMPLEMENTING THE OPERATORS" DEVOLUTION OF LTFRB'S FRANCHISING OVER TRICYCLES-FOR-HIRE TO THE CITY GOVERNMENT PURSUANT TO THE GOVERNMENT CODE OF 1991 (R.A. 7160)".

Be it ordained by the 8th Sangguniang Panlungsod ng Ormoc in Session assembled, that:

SECTION 1. Sec. 2, par. (d) of Ordinance No. 34 is hereby amended by deleting the phrase, "but not oftener than once every three (3) years", and will now read as follows:

X X X

"(d) Fix, impose and collect, and periodically review and adjust reasonable fees and other related charges in the regulations of tricycles-for-hire"; and SECTION 2. Art. 3 of Ordinance 34, as amended is hereby further amended to read as follows:

The foregoing schedule of fare rates should be posted prominently at the tricycle terminal, if any, and in a conspicuous part of the tricycle where said schedule can be easily seen by the passenger thereof. Failure to observe this requirement constitutes a violation of this Ordinance thereby making the operator and/or the driver of the tricycle liable to the penalty provided herein.

SECTION 3. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc.

RESOLVED, FURTHER, to furnish copies of this Ordinance, once each, to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Treasurer; Permits & Licensing Division Office, the PNP City Director and the PNP Precinct Commander-Precinct I, the ABC President (with request to give information to mga Barangay Chairmen), the DILG-CGO Officer, the Barangay Affairs Officer, the City Prosecutors' Office, the OCMODA, the FFDA, all others concerned, and at least three (3) copies be posted on Bulletin Boards at conspicuous places, -all in Ormoc City;
