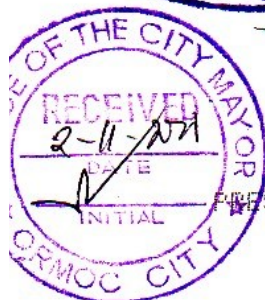
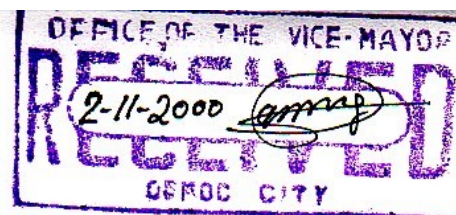
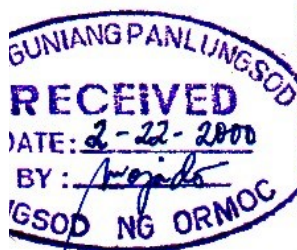

PREFATORY STATEMENT

The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances X X X and appropriate funds for the general welfare of the city X X X pursuant to Section 16 of the Code and in the proper exercise of the corporate powers of the city as provided in Rule IX of these Rules, and shall approve ordinances and pass resolutions necessary for the efficient and effective city government, and relative thereto, shall determine the positions and the salaries, wages X X X and other emoluments and benefits of the officials and employees paid wholly or mainly from city funds X X X X" (Article 99 with Par. (1) and Sub-par (viii) thereof - Rules and Regulations Implementing the Local Government Code of 1991. Underscoring supplied);

The Waterworks Superintendent II of the Ormoc Waterworks Division through a letter dated 14 October 1999 addressed the Honorable City Mayor Eufrocino M. Codilla, Sr., thru the Human Resource Management Officer, this city, has requested for an upgrading of two (2) positions namely: Public Utilities Regulations Officer I (Production Supervisor) and Public Utilities Regulations Officer I (Maintenance Supervisor) to Public Utilities Regulations Officer II to compensate the duties and responsibilities of the positions;

The Sangguniang Panlungsod ng Ormoc believes that there is a need of upgrading the aforementioned positions for efficient and effective services to the constituents;

ORDINANCE NO. 76

AN ORDINANCE UPGRADING THE POSITIONS OF PUBLIC UTILITIES REGULATIONS OFFICER I SG-11 (PRODUCTION SUPERVISOR) AND PUBLIC UTILITIES REGULATIONS OFFICER I SG-11 (MAINTENANCE SUPERVISOR) TO PUBLIC UTILITIES REGULATIONS OFFICER II SG-15 (PRODUCTION SUPERVISOR) AND PUBLIC UTILITIES REGULATIONS OFFICER II SG-15 (MAINTENANCE SUPERVISOR), OFFICE OF THE CITY ADMINISTRATOR, WATERWORKS DIVISION, THIS CITY.

BE IT ENACTED, by the EIGHTH SANGGUNIANG PANLUNGSOD ng ORMOC, That:

SECTION 1. There shall be upgraded two (2) positions under the Office of the City Administrator, Waterworks Division, this city, namely:
