EXPLANATORY

The Flood Miligation Project in Ormoc City (Phase II) is on-going. Part of which is the construction of the channel where the existing river course will be realigned/diverted permanently and that the target date for the completion of the entire project will be on March 15, 2001.

the said time frame, there is only one summer left and said the most appropriate time to construct the channel before the season comes, hence, there is a need to close a portion of Lilia Avenue from F Ablen St., to Anilao (Cantubo) Bridge on March 20, 2000 to give way for the construction of the channel where the existing river ourse will be realigned/diverted permanently, thereby all rebirles/equipment are to pass only at Alegria Bridge and will traverse along Aviles St., while light vehicles can utilize both Osmeña Extension Bridge and Alegria Bridge in entering and leaving the city proper. A traffic rerouting dry run was conducted on February 8-10, 2000 and same was generally successful and effective, except to some specific areas which are identified as Traffic chokepoints and bottlenecks which have been already studied and counter measures were also formulated.

In view of the need for the aforecited closure of Lilia Avenue from F. Ablen St. to the Anilao (Cantubo) Bridge, a letter request dated 23 February 2000 from Engr. Conrado D. Escobar, Project Manager, PMO-Major Flood Control Project Field Office, Fourth LED-DPWH, Ormoc City has been received by this Sanggunian Temporarily requesting to allow heavy vehicles to traverse Aviles Street starting March 20, 2000 until such time that the new Anilao Bridge will be open to traffic.

FOREGOING PREMISES CONSIDERED, on motion of City Mepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, duly jointly seconded by City Councilors Dennis Y. Capuyan and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

ORDINANCE NO. 78

AN ORDINANCE TEMPORARILY ALLOWING HEAVY VEHICLES TO TRAVERSE AVILES STREET STARTING MARCH 20, 2000 UNTIL SUCH TIME THAT THE NEW ANILAO BRIDGE WILL BE OPEN TO TRAFFIC.

BE IT ORDAINED, by the Eighth Sangguniang Panlungsod ag Ormoc,

SECTION 1. Heavy vehicles entering and/or leaving the city proper are temporarily allowed to traverse Aviles Steet, this city, starting March 20, 2000 until such time that the new Anilao Bridge will be open to traffic.

SECTION 2. <u>EFFECTIVITY</u>. This Ordinance shall take effect immediately upon its approval.
