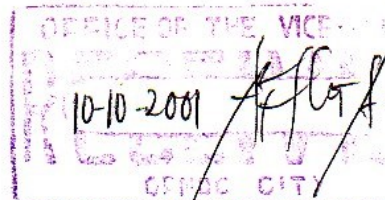


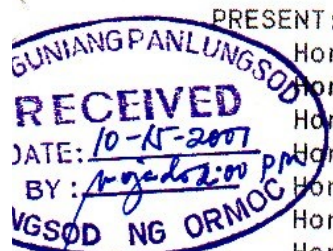

PREFATORY STATEMENT

Municipal Board Ordinance No. 81 series of 1968 was enacted by the 6th Municipal Board of Ormoc City to declare as one-way traffic the portion of Osmeña Street from its corner on Real Street Eastward including Agua Dulce Street up to the latter's corner on C. Aviles Street and, also, the portion of Rizal Street from its corner on C. Aviles Street Northward up to its opposite corner on Osmeña Street. The portion of Osmeña Street was opened for only one-way traffic when the North Diversion Road (Hermosilla Drive) was still under construction while the portion of Rizal Street was also declared a one-way traffic for the convenience and safety of market goers along the narrow street where the public market before stands. In 1979 when the North Diversion road was opened for traffic absorbing the flow of all cargo trucks which used to run along Osmeña Street and the transfer of the City Public Market to the reclaimed area in Sabang Beach, the First Sangguniang Panlungsod ng Ormoc passed Ordinance No. 22, series of 1979 repealing Municipal Board Ordinance No. 81, series of 1968 by restoring to two-way traffic the portion of Osmeña Street from its corner on Real Street to the corner of San Pablo Street maintaining one-way traffic on Agua Dulce Street and likewise restoring to two-way traffic the portion of Rizal Street from Corner C. Aviles Street to Osmeña Street.

Recently, the Chairman, Committee on Laws and Ordinances in his move to propose for the enactment of Ormoc City Code of General Ordinances found out while making an inventory of all city ordinances that there was no ordinance passed declaring Rizal Street as one-way traffic from corner C. Aviles Street to Osmeña Street. Likewise, there was no ordinance passed opening Agua Dulce Street into two-way traffic.

There is, therefore, now a need to repeal Municipal Board Ordinance No. 81, series of 1968 and Ordinance No. 22, s. of 1979 of the First Sangguniang Panlungsod ng Ormoc considering that Rizal Street which is supposed to be a two-way Street is being used as one-way street and Agua Dulce Street which is supposed to be one-way street is opened to two-way traffic, while a new ordinance may be in order to declare at all times a portion of Rizal Street, Ormoc City.

WHEREFORE, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, duly seconded by City Councilor Ruvinieu E. Mendola; be it

RESOLVED, to adopt:

ORDINANCE NO. 83

AN ORDINANCE TO REPEAL MUNICIPAL BOARD ORDINANCE NO. 81, SERIES OF 1968 AND ORDINANCE NO. 22, S. OF 1979 OF THE FIRST SANGGUNIANG PANLUNGSOD NG ORMOC.

BE IT ORDAINED, by the 9th SANGGUNIANG PANLUNGSOD ng ORMOC, that:

SECTION 1. Repeal of Municipal Board Ordinance No. 81, series of 1968 and Ordinance No. 22, s. of 1979 of the First Sangguniang Panlungsod ng Ormoc. Municipal Board Ordinance No. 81, series of 1968 and Ordinance No. 22, s. of 1979 of the First Sangguniang Panlungsod ng Ormoc is hereby repealed.

SECTION 2. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
