PREFATORY STATEMENT

WHEREAS, Domingo Costas Veloso was first elected to Congress in 1946, re-elected in 1949 and in 1953, serving as a Representative for twelve (12) years of the Second Congressional District of Leyte comprising at that time the Municipalities in the coastal mid-western part of Leyte including Ormoc, which was then a municipality;

WHEREAS, had it not been for his untiring efforts during his incumbency, Ormoc City would not have been what it is today, peaceful and dynamic city;

WHEREAS, it is but ironic to know that up to the present Domingo Costas Veloso has never been given a place of honor being the author of House Bill No. 609, which eventually became Republic Act No. 179 creating the Municipality of Ormoc as a Chartered City;

WHEREAS, as a fitting tribute to the late Congressman Domingo Costas Veloso, this august Body finds it most worthy to consider naming the street from the corner of Veterans Avenue in Barangay Punta to the corner of Ormoc-Merida Highway in Barangay Cogon as DOMINGO C. VELOSO STREET.

RESOLVED, to adopt:

ORDINANCE NO. 098

AN ORDINANCE NAMING THE STREET FROM THE CORNER OF VETERANS AVENUE IN BARANGAY PUNTA TO THE CORNER OF ORMOC-MERIDA HIGHWAY IN BARANGAY COGON AS DOMINGO C. VELOSO STREET.

BE IT ORDAINED, by the NINTH SANGGUNIANG PANLUNGSOD NG ORMOC, That:

SECTION 1. The Street from the corner of Veterans Avenue in Barangay Punta to the corner of Ormoc-Merida Highway in Barangay Cogon be named as DOMINGO C. VELOSO STREET;

SECTION 2. <u>EFFECTIVITY</u>. - This Ordinance shall take effect ten (10) days from its approval and after having published the same in full for a period of three (3) days in two (2) conspicuous and accessible places, pursuant to the provisions of Section 188 of R.A. 7160.

ENACTED, January 16, 2003.

RESOLVED, FURTHER, to furnish copies of this Ordinance one each to the National Historical Institute, Manila; to His Nonor, the City Mayor of Ormoc, Carmelo J. Locsin; the City Engineer's Office, the Post Master, Post Office, Ormoc City, to Sra. Nilda Neri Veloso, Baybay, Leyte and sufficient copies thereof be posted on Bulletin Boards at conspicuous places, all in Ormoc City.
