

PREFATORY STATEMENT

The City Government of Ormoc has granted a tax amnesty for those yers who were not able to pay their real estate taxes and also to taxpayers those delinquent taxpayers;

However, with such a program having been implemented, it turned out most of the taxpayers still were not able to pay nor meet the deadline set on December 31, 2002;

Lately, however, the President, Filipino Chinese Chamber Commerce and Industry of Ormoc City, Inc., Mr. Melchor Q. Sia, through a letter dated 08 January 2003 has requested the Honorable Mayor through the Sangguniang Panlungsod for an extension of amnesty up to May 2003 citing therein the reasons for such non-payment;

Finding said request meritorious and reasonable, this august Body believes that the same be accorded due course of action;

PREMISES CONSIDERED, on motion of City FOREGOING Demosthenes F. Tugonon, Chairman, Committee on Ways & Means, duly seconded by City Councilor Rafael C. Omega, Jr.; be it

RESOLVED, to adopt:

ORDINANCE NO. 100

AN ORDINANCE EXTENDING THE DEADLINE OF THE TAX AMNESTY PROGRAM OF THE CITY OF ORMOC FROM DECEMBER 31, 2002 TO MARCH 31, 2003.

BE IT ORDAINED, by the 9th Sangguniang Panlungsod ng Ormoc; That:

SECTION 1. This Ordinance shall be known as "AN ORDINANCE EXTENDING THE DEADLINE OF THE TAX AMNESTY PROGRAM OF THE CITY OF ORMOC FROM DECEMBER 31, 2002 TO MARCH 31, 2003".

SECTION 2. This Ordinance on tax amnesty shall apply only on real properties.

SECTION 3. The extension granted under this order will run from December 31, 2002 to March 31, 2003 only;

SECTION 4. This Ordinance shall take effect immediately upon its approval.

ENACTED, January 30, 2003.

RESOLVED, FURTHER, to furnish copies of this Ordinance each to the Honorable City Mayor; the City Administrator, the City Treasurer, the City Assessor and others concerned, -in Ormoc City;
