PREFATORY STATEMENT

ESTEBAN CEBUANO CONEJOS, SR., was born on August 2, 1907 in Tapilon, Daanbantayan, Cebu to the couple Getulio Conejos and Marcela Cebuano.

Before joining politics, he was an active member of the Philippine serving from the rank of Lieutenant up to Major. He was also a member of the United States Armed Forces to the Far East (USAFFE) and a Bataan Veteran.

As a government servant, he was once the Chief of Police of Ormoc City in 1947, then became City Councilor in 1947-1955, appointed City Mayor of Ormoc by President Carlos P. Garcia in 1956, then elected City Mayor in 1957-1967.

After serving as City Mayor of Ormoc in 1967, he went back to practice his profession as a lawyer until his death on July 28, 1989. He was married to Rosario V. Benedicto with whom they had seven (7) children namely Aumar, Marisol, Lynda, Esteban, Jr., Manuel, Jose and Rene.

He was responsible in establishing the Government Center where the new city hall is under construction as well as the opening of roads within the said government center;

As a fitting tribute to the late City Mayor Esteban C. Conejos, Sr., this august Body finds it most worthy to consider naming the street from the corner of F. Ablen Street towards the foot of the bridge of Barangay Don Felipe Larrazabal at Osmeña Street as Esteban C. Conejos Street.

ORDINANCE NO. 103

AN ORDINANCE NAMING THE STREET FROM THE CORNER OF F. ABLEN STREET TOWARDS THE FOOT OF THE BRIDGE OF BARANGAY DON FELIPE LARRAZABAL AT OSMEÑA STREET AS ESTEBAN C. CONEJOS STREET.

BE IT ORDAINED, by the 9th SANGGUNIANG PANLUNGSOD ng ORMOC, That:

SECTION 1. The street from the corner of F. Ablen Street towards the foot of the bridge of Barangay Don Felipe Larrazabal at Osmeña Street as ESTEBAN C. CONEJOS STREET;

SECTION 2. <u>EFFECTIVITY</u>- This Ordinance shall take effect ten (10) days from its approval and after having published the same in full for a period of three (3) days in two (2) conspicuous and accessible places, pursuant to the provisions of Section 188 of R.A. 7160.
