PREFATORY STATEMENT

The Honorable Chairman, Committee on Transportation and Communications conducted a Public Hearing on April 04, 2003, at the Sangguniang Panlungsod Session Hall regarding the increase in fare rates for Motorized Tricycles as requested by the OCMODA represented by its President.

The increase in fare rates was due to the increase also of fuel, spare parts and other accessories needed in the maintenance of the said Motorized Tricycle. Notwithstanding the fact that some operators have increased also the rental for their units specially if said units are new.

After a thorough discussion, the operators, drivers, riding public, and the members of the said committee, have agreed to have an increase in fare rates from P3.00 to P3.50 only within the city proper, thereby amending Art. III, Chapter II, Title 12, otherwise known as "Ormoc City Motorized Tricycle-For-Hire Franchising Ordinance" of the Code of General Ordinances of Ormoc City, increasing the minimum fare rate for Motorized Tricycle from P3.00 to P3.50 within the City Proper;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Jovencio A. Laurente, Chairman, Committee on Transportation & Communications, duly seconded by City Councilor Gregorio A. Yrastorza, Jr.; be it

RESOLVED, to adopt:

ORDINANCE NO. 105

AN ORDINANCE TO AMEND SECOND PARAGRAPH OF ARTICLE III, CHAPTER II, TITLE 12, OTHERWISE KNOWN AS "ORMOC CITY MOTORIZED TRICYCLE-FOR-HIRE FRANCHISING ORDINANCE" OF THE CODE OF GENERAL ORDINANCES, INCREASING THE MINIMUM FARE RATE FOR MOTORIZED TRICYCLE FROM P3.00 TO P3.50 WITHIN THE CITY PROPER.

BE IT ORDAINED, by the 9th Sangguniang Panlungsod ng Ormoc in SESSION, that:

SECTION 1. Art. III, Chapter II, Title 12, otherwise known as "Ormoc City Motorized Tricycle-For-Hire Franchising Ordinance" of the Code of General Ordinances of Ormoc City, increasing the minimum fare rate for Motorized Tricycle from P3.00 to P3.50 within the City Proper;

FARES:

The fare shall be established at a level that will provide the operator a reasonable return, or profit and still be affordable to the general public.

The new fare rate shall be an additional Fifty Centavos (P.50) of the existing rate within the city proper. The city proper shall comprise Barangay District 1 to 28 except Barangay District 29.

Until such time that the Sangguniang Panlungsod shall prescribe otherwise, the official rate within the city proper of Ormoc is P3.50;

The aforecited fare rate should be posted prominently at the tricycle terminal, if any, and in a conspicuous part of the tricycle where said schedule can be easily seen by the passenger thereof.

Failure to observe this requirement constitute a violation of this ordinance thereby making the operator and/or the driver of the tricycle liable to the penalty provided herein;


SECTION 2. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc.

ENACTED, September 11, 2003.




