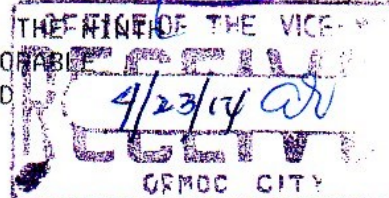

PREFATORY STATEMENT

PRESENTED to this august Body for consideration is a request from
OCMODA to increase the ten (10) year old model requirement on
motorcycles to twelve (12) years from registration of the motorcycle.

It can be recalled that such authority has been devolved to the
local government unit, thus the City Government of Ormoc is authorized
to implement the franchising authority over motorized tricycle for hire
from the LTRRB.

Considering said request to be reasonable, the same must be
accorded due course of action;

FOREGOING PREMISES CONSIDERED, on motion of the City Councilor
Jovencio A. Laurente, Chairman, Committee on Transportation &
Communications, jointly seconded by City Councilors Fernando P. Parrilla
and Fe S. Lladoc; be it

RESOLVED, to adopt:

ORDINANCE NO. 110

AN ORDINANCE AMENDING SECTION 3 PAR. A ART. 1 CHAPTER II
TITLE 12 OF THE CODE OF GENERAL ORDINANCES OF ORMOC
CITY INCREASING THE TEN (10) YEAR OLD MODEL REQUIREMENT
ON MOTORCYCLES TO TWELVE (12).

SECTION 1. Section 3 par. A Art. 1, Chapter II Title 12 of the
Code of General Ordinances of Ormoc City reads as follows:

Sec. 3. Definition of Terms.

a) TRICYCLE-FOR-HIRE is a motor vehicle composed of a motorcycle fitted with a single-wheeled side car or a motorcycle with a two-wheeled cab operated to render service to the general public for a fee; It shall have a maximum number of passenger of six (6) seating capacity; (ORDINANCE NO. 89, SERIES OF 2002);

The motorcycle should at least be of 100 CC power and not beyond ten (10) years old model; (ORDINANCE NO. 89, SERIES OF 2002)

Operators shall employ only drivers duly licensed by Land Transportation Office for tricycle for hire. Certificates of Seminars of Defensive and Safety Driving is included as a requirement for granting franchise.

As amended, Sec. 3 now reads as follows:

Sec. 3. Definition of Terms.

a) TRICYCLE-FOR-HIRE is a motor vehicle composed of a motorcycle fitted with a single-wheeled sidecar or a motorcycle with a two-wheeled cab operated to render service to the general public for a fee; It shall have a maximum member of passengers of six (6) seating capacity; (ORDINANCE NO. 89 SERIES OF 2002);

The motorcycle should at least be of 100 CC power and not beyond twelve (12) years from registration of the same;

Operators shall employ only drivers duly licensed by Land Transportation Office for tricycle for hire. Certificates of Seminar of Defensive and Safety Driving is included as a requirement for granting franchise.

Sec. 2. EFFECTIVITY. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc;


ENACTED, April 22, 2004.

RESOLVED, FURTHER, to furnish copies of this Ordinance, one each to His Honor, the City Mayor; the City Administrator, the City Treasurer, the City Legal Officer, the City Licensing Division, the President, OCMODA and others concerned, -in Ormoc City;


CARRIED by Ten (10) Affirmative Votes with One (1) Abstention registered by City Councilor Cheryl L. Alfar.
