RESOLVED, to adopt:

### ORDINANCE NO. 111

AN ORDINANCE ADDING CHAPTER IX OF TITLE ELEVEN (TRAFFIC REGULATION) OF ORDINANCE NO. 2003-130A ENTITLED: ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC" DECLARING AS LOADING AND UNLOADING AREA FOR ALL MOTOR VEHICLES DURING SCHOOL DAYS (MONDAY TO FRIDAY) FROM 6:00 A.M. TO 5:30 P.M. ALONG THE WAITING SHED FRONTING THE ORMOC CITY CENTRAL SPED CENTER, CARLOS TAN STREET, ORMOC CITY.

BE IT ORDAINED, by the 9th Sangguniang Panlungsod ng Ormoc, That:

Ord. No. 111

SECTION 1. The following portion of the City Street is hereby declared as loading and unloading area for all motor vehicles during school days from 6:00 A.M. to 5:30 P.M..

Public waiting shed fronting the Ormoc Central SPED Center, Carlos Tan Street, this city.

SECTION 2. Any violation of the provision of this Ordinance shall be punished by a fine of Five Hundred Pesos (P500.00) or an imprisonment at the discretion of the court.

SECTION 3. Any Ordinance or provision thereof in conflict with this Ordinance is hereby repealed.

SECTION 4. This Ordinance shall take effect immediately upon its approval.

ENACTED, May 27, 2004.

RESOLVED, FURTHER, to direct the Chief of Police of Ormoc City to coordinate with the City Engineer in putting up the necessary traffic signs for the purpose of this ordinance;

RESOLVED, FURTHER, to furnish copy of this ordinance each to the Municipal Trial Court in Cities, the City Prosecutor's Office, the Chief of Police, the City Engineer, the City Treasurer, the Land Transportation Office, and the Barangay Councils of Barangay District X and District XVIII, -all in Ormoc City;
