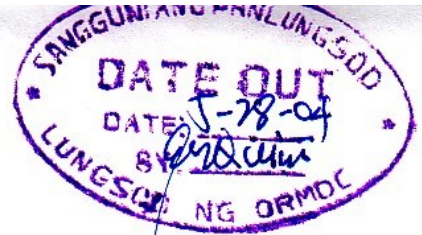

PREFATORY STATEMENT

The Sangguniang Panlungsod ng Ormoc as the lawmaking body of the city, is by law granted the power to regulate traffic on all streets and bridges. This authority can be exercised through an Ordinance enacted for the purpose.

Some streets in this city need to be declared as one-way traffic in order to ease the flow of traffic and for public safety purposes;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, duly seconded by City Councilor Demosthenes F. Tugonon; be it

RESOLVED, to adopt:

ORDINANCE NO. 112

AN ORDINANCE ADDING CHAPTER VIII OF TITLE ELEVEN (TRAFFIC REGULATION) OF ORDINANCE NO. 2003-130A, ENTITLED: "AN ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC" DECLARING AS ONE-WAY TRAFFIC, (1) SAN PEDRO STREET FROM THE CORNER OF OSMEÑA STREET TO THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS; (2) CARLOS TAN STREET FROM THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS TO ARRADAZA STREET; AND (3) ARRADAZA STREET FROM THE CORNER OF ARRADAZA AND CARLOS TAN STREETS TO THE CORNER OF ARRADAZA STREET AND OSMEÑA STREET DURING SCHOOL DAYS (MONDAY TO FRIDAY) FROM 6:00 A.M. TO 5:30 P.M.

BE IT ORDAINED, by the 9th Sangguniang Panlungsod ng Ormoc, That:

Ord. No. 112

SECTION 1. The following portions of the city streets are hereby declared as one-way traffic during school days (Monday to Friday) from 6:00 A.M. to 5:30 P.M.

(1) San Pedro Street from the corner of Osmeña Street to the corner of San Pedro and Carlos Tan Streets;

(2) Carlos Tan Street from the corner of San Pedro and Carlos Tan Streets to Arradaza Street; and

(3) Arradaza Street from the corner of Arradaza and Carlos Tan Streets to the corner of Arradaza Street and Osmeña Street;

SECTION 2. Any violation of the provisions of this ordinance shall be punished by a fine of Five Hundred Pesos (P500.00) or an imprisonment of 5 to 10 days or both such fine or imprisonment at the discretion of the court.

SECTION 3. Any ordinance or provision thereof in conflict with this ordinance is hereby repealed.

SECTION 4. This Ordinance shall take effect upon its approval.


ENACTED, May 27, 2004.


