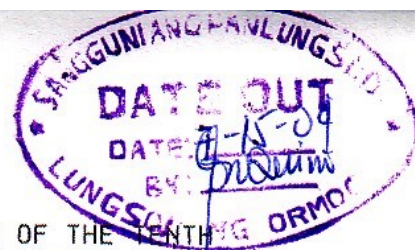

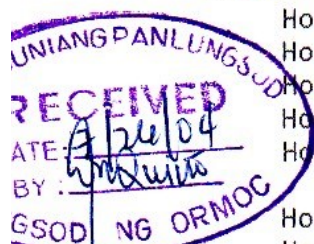

EXPLANATORY NOTE

Section 50 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in part provides: "(a) On the first regular session following the election of its members and within ninety (90) days thereafter, the sanggunian concerned shall adopt or update its existing rules of procedures".

During our First Regular Session on June 30, 2004, Resolution No. 2004-001 was passed adopting in toto as the 10th Sangguniang Panlungsod's Ad Interim Rules and Procedures, the Rules and Procedures of the 9th Sangguniang Panlungsod. However, there are certain provisions therein which require to be updated, specifically Section 1 of Rule III, Section 1 of Rule IV and Rule VII of aforementioned Rules. Hence, this proposed Ordinance.

FOREGOING PREMISES considered, on motion of City Councilor Mariano Y. Corro, duly seconded by City Councilor Sotero M. Pepito; be it

RESOLVED, to adopt:

ORDINANCE NO. 114

AN ORDINANCE AMENDING SECTION 1 OF RULE III, SECTION 1 OF RULE IV AND RULE VII OF TITLE IV (INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG PANLUNGSOD) OF ORDINANCE NO. 2003-130A, ENTITLED: "AN ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC".

BE IT ORDAINED, by the 10th Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Section 1, Rule III of the Internal Rules of Procedure of the Sangguniang Panlungsod is hereby amended to read as follows:



"Section 1. For purposes of efficient supervision and administration of the city, there are hereby created eleven (11) Sangguniang Districts, the composition of which shall from time to time be determined and approved by the members (COUNCILORS) of the Sanggunian, until revised, the division and composition of the different barangays are as follows:

That for each Sangguniang District thus created, a regular Councilor shall be assigned as Councilor-in-Charge therein, and which assignment shall be determined by proper resolution approved by the council. However, Sangguniang District I shall be assigned to the Presiding Officer. The aforementioned assignment shall be reshuffled once every two (2) years or at any time upon proper resolution approved by the Council.

SECTION 2. Section 1 of Rule IV of the Internal Rules of Procedure of the Sangguniang Panlungsod is hereby amended to read as follows:



"Section 1 - STANDING COMMITTEES. - In the Inaugural Session or thereafter, the Sangguniang Panlungsod shall organize the following Standing Committees with powers and prerogatives especially on matters herein mentioned.

"STANDING COMMITTEES OF THE 10TH SANGGUNIANG PANLUNGSOD NG ORMOC"

COMMITTEE ON AGRICULTURE AND FISHERIES - All matters relating to agriculture, food production and agri-business, agricultural economic research, soil survey and conservation; agricultural education and extension services, animal industry and livestock quarantine and farm credits. All matters relating to fisheries and aquatic resource preservation and development of fishing grounds; and construction of fish ponds, corrals, oyster beds, and regulatory measure therefor.

COMMITTEE ON ECONOMIC ENTERPRISE (MARKET & SLAUGHTERHOUSE) - Matters relating to the economic enterprise of the city such as the maintenance and operation of public market, slaughterhouse, ORWASA, superdome and the like and other market projects and allied matters.

COMMITTEE ON PUBLIC INFORMATION - Matters relating to dissemination of information on projects and performances of the city administration through the press, radio, TV and other media.

COMMITTEE ON CITIES SISTERHOOD PROGRAM - Matters relating to establishing a tie-up with sister cities and promoting an exchange program in public administration, culture and socio-economic activities.

COMMITTEE ON SOCIAL WELFARE - All matters related to public and social welfare and ameliorative services, public social services for the disadvantaged groups in society including the elderly, disabled, street children, drug dependents, criminal offenders and day care centers;

COMMITTEE ON WOMEN AND FAMILY - All matters related to women and family, measures to protect working women by providing safe and healthful working conditions taking into account their maternal functions, and such facilities and opportunities that will enhance their welfare and potentials, measures to protect the rights of spouses and children, including assistance for proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development, measures to protect the rights of families or family associations to participate in the planning and implementation of policies and programs that affect them and other assistance that safeguard the development of women and family.

COMMITTEE ON TOURISM - Matters relating to the management, accommodation and guidance of tourists and other programs relating to and/or pertinent to the development of tourism industry.

COMMITTEE ON COOPERATIVES, LIVELIHOOD AND COTTAGE INDUSTRY - Matters relating to cooperatives and cooperative development, small scale industries recognized by the Department of Trade and Industry and livelihood.

COMMITTEE ON GENERAL SERVICES - Matters relating to maintenance of janitorial, messengerial, auxiliary and other utility services.



COMMITTEE ON MANPOWER DEVELOPMENT - Matters relating availability of human resources or personnel for competent services in industries in the community.

COMMITTEE ON EDUCATION AND CULTURE DEVELOPMENT - Matters relating to education and culture, local schools, colleges and universities, libraries and museums, non-formal and community adult education, scientific and technological research, development and advancement, preservation and enrichment of filipino arts and culture.

COMMITTEE ON GOOD GOVERNMENT AND ETHICS - Matters relating to investigation of malfeasance, misfeasance and nonfeasance of officers and employees of the government and other matters of public interest.

COMMITTEE ON HEALTH - All matters related to health, sanitation and hygiene, health centers, medical hospitals and clinics, purchase of medicine and other health and sanitary measure.

STEERING COMMITTEE - Matters relating to determination of the order in which business of the Sangguniang Panlungsod shall be taken up.

COMMITTEE ON ENERGY DEVELOPMENT & CONSERVATION - Matters relating to preservation and distribution of electricity, petroleum products and the like.

COMMITTEE ON NATURAL RESOURCES AND ENVIRONMENTAL CONTROL - All matters related to human ecology and settlements, environmental protection, exploration, development, utilization and conservation of natural resources, including flora and fauna and solid waste management.

COMMITTEE ON POLICE, FIRE AND PUBLIC SAFETY - Matters related to police matters, maintenance of peace and order, protective services, traffic rules and regulations, fire prevention and control measure, jail management.

COMMITTEE ON PUBLIC PROPERTIES - Matters relating to acquisition and disposition of public properties, titling and registration of real properties, barangay and school sites, etc.

COMMITTEE ON RURAL DEVELOPMENT & BARANGAY AFFAIRS - Matters relating to development of barangays and barangay districts.

COMMITTEE ON FINANCE AND APPROPRIATION - Matters relating to funds for the expenditures of the city government and for the payment of public indebtedness, claims against the government, appropriation or adjustment of funds and generally, all matters relating to public expenditures.

COMMITTEE ON INTERNAL RULES - All matters related to order of business, the implementation of national laws and enforcement of local ordinances, revision and interpretation of the sangguniang internal rules of procedures and matters relating to privileges and disorderly conduct of the members of the sanggunian.

COMMITTEE ON LAWS AND ORDINANCES - Matters relating to propose penal ordinances or proposed measures amending city existing penal ordinances or measures involving legality, lease of lots, donations, naming of streets and schools and legal order from the courts on city ordinances.



COMMITTEE ON WAYS AND MEANS - All matters related to taxes, fees, charges, loans, study and revision of tax measures and generation of other sources and forms of revenues from both public and private sectors, including codification of revenue ordinances.

COMMITTEE ON HUMAN RIGHTS - Matters relating to violation of human rights and protection thereof.

COMMITTEE ON AGRICULTURAL AND INDUSTRIAL LABOR AND AGRARIAN REFORM - Matters relating to agricultural and industrial labor, stevedoring, arrastre service and the like. Matters relating to agrarian and social problem.

COMMITTEE ON INFRASTRUCTURE - All matters related to planning, construction, maintenance, improvement and repairs of public buildings, highways, roads and bridges, parks, monuments, playgrounds and other public edifices, drainage, sewerage and flood control and protection; irrigation and water utilities.

COMMITTEE ON TRADE AND COMMERCE - Matters relating to commercial transactions and the marketing of products and merchandise.

COMMITTEE ON COMMUNICATIONS AND TRANSPORTATION - All matters related to planning, modernization, installation and construction of telecommunications facilities as well as public and private transportation facilities.

COMMITTEE ON YOUTH AND SPORTS DEVELOPMENT - All matters relating to the upliftment of the moral, physical and intellectual well-being and development of youth. Matters related to development of sports, operation and maintenance of sports complex.

COMMITTEE ON ZONING, BEAUTIFICATION AND URBAN DEVELOPMENT - Matters relating to beautification of public or semi-public places, zoning of industrial, commercial and residential districts, subdivision of lots, and the like; zoning and human settlements planning and development of urban poor.

SECTION 3. Rule VII of the Internal Rules of Procedure of the Sangguniang Panlungsod is hereby amended to read as follows:

"RULE VIII - HOW BUSINESS CONDUCTED"

The Order of Business of the Sangguniang Panlungsod shall be as follows:

- I. Call to Order
- II. Invocation
- III. Singing of the National Anthem
- IV. Pledge of Allegiance to the Flag
- V. Roll Call
- VI. Approval of Minutes of Previous Session
- VII. Reference of Business
  - a. Proposed Ordinances
  - b. Proposed Resolutions
  - c. Petitions or Requests
  - d. Other Communications
- VIII. Calendar of Business
  - a. Unfinished Business
  - b. Business for the Day
  - c. Unassigned Business



- IX. Business on Third and Final Reading
- X. Other Matters
- XI. Adjournment

The INVOCATION shall be led by a Member of the Council on a rotation basis to be determined by the Presiding Officer.

Hereunder are suggested prayers that may be used in the Invocation. However, the Member assigned to lead the invocation may adopt his own prayers provided that the same will not be more than three (3) minutes.

SECTION 4. This Ordinance shall take effect immediately upon its approval.





CARRIED UNANIMOUSLY.


