EXPLANATORY NOTE

Government Units are empowered, under the Rules Regulations Implementing the Local Government Code of 1991, particularly Rule VIII, Article 43 thereof, to temporarily or permanently close or open any road, alley or park or square within its jurisdiction through an Ordinance.

of the said Implementing Rules and Article enumerates the instances whereby a Local government Unit may close any national or local road, alley, park of or square, the duration of which shall be determined by the local chief executive concerned in a written order, Letter (b) of said article provides:

"Art. 45. Temporary Closure -

X XX XX X

(b) An LGU may temporarily close and regulate the use of any local street, road, thoroughfare, or public place where shopping malls, Sunday markets, flea or night markets, or shopping areas may be established goods, merchandise. foodstuff, commodities, or articles of commerce may be sold and dispensed to the general public.

Relying on the aforecited provision of the Rules and Regulations Implementing the Local Government Code of 1991, the Honorable City Mayor of Ormoc, through a letter, requested this august Body for the passage of an Ordinance temporarily closing part of Macaasin St., and part Burgos and J. Navarro Streets, this city;

FOREGOING PREMISES CONSIDERED, on motion of Ruben R. Capahi, Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilors Eduardo P. Tan & Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

ORDINANCE NO. 118

AN ORDINANCE TEMPORARILY CLOSING MACAASIN STREET AND PART OF BURGOS AND J. NAVARRO STREETS, FOR THE ESTABLISHMENT OF A SHOPPING AREA WHERE GOODS, MERCHANDISE, FOODSTUFF, COMMODITIES AND OTHER ARTICLES OF COMMERCE SHALL BE SOLD AND DISPENSED TO THE GENERAL PUBLIC, THE DURATION OF WHICH SHALL BE SPECIFIED BY THE CITY MAYOR.

BE IT ORDAINED by the Tenth Sangguniang Panlungsod ng Ormoc, that:

SECTION 1. The portion of Burgos and J. Navarro Streets, this city, fronting the Mini-forest, and Macaasin Street, at the back of the Ormoc City Hall, shall be temporarily closed for the establishment of a shopping area where goods, merchandise, foodstuff, commodities and other articles of commerce shall be sold and dispensed to the general public, the duration of which shall be specified by the City Mayor.

SECTION 2. Prohibitions. No person shall erect or place any stall, or any other structure used for vending any kind of commodity, outside of the area specified by Section One hereof. A violation of this section shall be a ground for automatic revocation of the vendor's permit to sell within the closed area.

SECTION 3. Effectivity. This Ordinance shall take effect immediately upon its approval.
