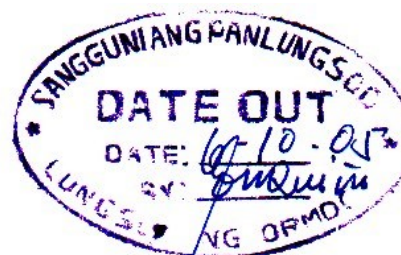
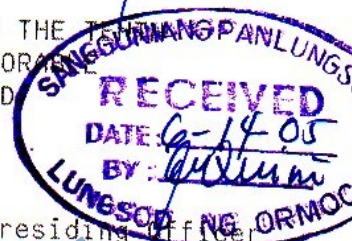

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

ORDINANCE NO. 121

AN ORDINANCE AMENDING SECTION 1, RULE V OF THE RULES AND PROCEDURES OF THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY.

BE IT ORDAINED, by the Tenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Section 1 of Rule V of the Rules and Procedures of the Sangguniang Panlungsod of Ormoc is hereby amended by changing the time of Pre-Session Caucus from 8:30 in the morning to 9:30 in the morning, thus, Section 1, Rule V now reads:

RULE V - SESSION, QUORUM AND ATTIRE

SECTION 1. PRE-SESSION CAUCUS - Shall be held every Monday at 9:30 in the morning at the Sangguniang Panlungsod Conference Room for the purpose of determining and discussing the agenda for the regular session provided however, that if a Monday happens to be a holiday the Pre-Session Caucus shall be held on the next succeeding business day at the same time and place or on any day as may be agreed upon by the Kagawad.


SECTION 2. EFFECTIVITY - This Ordinance shall take effect immediately upon its approval.
