EXPLANATORY NOTE

A petition has been filed by the Ormoc City Motorcab Operators and Drivers Association (OCMODA) asking for a ONE PESO (P1.00) fare increase in view of the continued increase in the prices of gasoline and other petroleum products.

The present fare for tricycles was approved sometime March 18, 2004 and with the latest development in the oil industry wherein prices of which keep on increasing, it is also expected that operators of motorcabs have to increase the rentals on boundaries of their units to cope up with the rising prices of spare parts reducing thereby the income of motorcab drivers, thus making it very difficult to make both ends meet.

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Jose C. Alfaro, Jr., Vice Chairman, Committee on Transportation and Communications, duly seconded by City Councilor by Mariano Y. Corro; be it

RESOLVED, to adopt:

ORDINANCE NO. 122

AN ORDINANCE AMENDING ORDINANCE NO. 109 DATED MARCH 18, 2004 ENTITLED; "AN ORDINANCE AMENDING TITLE XII OF THE CODE OF GENERAL ORDINANCES OF ORMOC CITY BY ADDING CHAPTER IV, ENTITLED: AN ORDINANCE AMENDING ORDINANCE NO. 105 SERIES OF 2003 OF ORMOC CITY BY INCREASING THE MINIMUM FARE RATE FOR MOTORIZED TRICYCLE AND ESTABLISHING A NEW RATE FOR ORMOC CITY AND ITS BARANGAYS".

BE IT ORDAINED, by the TENTH SANGGUNIANG PANLUNGSOD NG ORMOC That:

SECTION 1. Ordinance No. 109 dated March 18, 2004 of the Sangguniang Panlungsod ng Ormoc is hereby amended to read as follows:

FARES:

The fare shall be established at a level that will provide the operator a reasonable return or profit and still be affordable to the general public.

The new fare rate shall be the existing rate within the city and barangays.

Until such time that the Sangguniang Panlungsod shall prescribe otherwise, the official rate shall be in accordance with the following:

The foregoing schedule of fare rates should be posted prominently at the tricycle terminal, if any, and in a conspicuous part of the tricycle where said schedule can be easily seen by the passenger thereof.

Failure to observe this requirement constitute a violation of this Ordinance thereby making the operator and/or the driver of the tricycle liable to the penalty provided herein.


SECTION 2. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc.


