PREFATORY STATEMENT

PRESENTED to this Sanggunian for consideration is a letter dated 04 July 2005 from the Honorable City Mayor Eric C. Codilla requesting for the passage of an Ordinance in compliance with Section 4.1 of Budget Circular No. 2004-3A of the Department of Budget and Management. The subject of said Circular is the Conversion of Positions Performing Staff/Non-Technical Functions;

WHEREAS, Budget Circular No. 2004-3A was issued for the purpose of amending the pertinent implementing guidelines provided under Budget Circular (BC) No. 2004-3A dated March 6, 2004;

WHEREAS, paragraph 4.1 of Budget Circular No. 2004-3A provides that:

"4.1 In line with local autonomy the conversion of positions in all LGU's performing staff and non-technical functions to the new classes authorized under BC No. 2004-3 shall be done by the LGUs and included in the Personnel Schedule of the 2005 LGU budget to be submitted to the Sangguniang Panlalawigan/DBM for review. If the conversion of said positions is not included in the FY 2005 budgets of LGU's due to time constraints, a special provision in the respective appropriation ordinances for the FY 2005 budgets may be cited that the local chief executive may cause the conversion of said positions during the FY 2005 budget executive phase, provided that such conversion shall not involve any change in salary grade. If such special provision is not included, then the conversion of said positions may be effected through a Sangguniang Resolution".

WHEREAS, said Conversion of Positions Performing Staff/Non-Technical Functions was also recommended by the Regional Director, Department of Budget & Management, through a letter dated February 11, 2005 which is quoted hereunder as follows:

"2.8 That the agency, shall adopt the conversion of positions performing staff/non-technical functions in accordance with the provisions of Budget Circular 2004-3 and 2004-3A. The same may be implemented during the budget execution phase through a separate Sangguniang Resolution provided that such conversion should not involve a change in Salary Grade".

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilors Mariano Y. Corro and Claudio P. Larrazabal; be it

RESOLVED, to enact:

ORDINANCE NO. 124

AN ORDINANCE ADOPTING THE CONVERSION OF POSITIONS PERFORMING STAFF/NON-TECHNICAL FUNCTIONS IN COMPLIANCE WITH SECTION 4.1 OF BUDGET CIRCULAR 2004-3A OF THE DEPARTMENT OF BUDGET AND MANAGEMENT.

BE IT ENACTED, by the Tenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. COVERAGE. This Ordinance shall cover all positions enumerated in the Personnel Schedule of the 2005 Ormoc LGU Budget submitted to the Sangguniang Panlungsod/DBM for review. Copies of Personal Schedule for Ormoc LGU is hereto attached and made as part and parcel of this ordinance.

SECTION 2. NON-MODIFICATION OF SALARY GRADE AND PERSONNEL APPOINTMENT. It is the clear intent of this Ordinance that the conversion shall only refer or apply to the positions affected or their official designation. The conversion herein ordained shall not involved any change in the salary grade for each position.


SECTION 3. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.

ENACTED, August 04, 2005.

RESOLVED, FURTHER to furnish copies of this Ordinance one each to His Honor, the City Mayor, the City Administrator, the City Treasurer, the City Accountant, the City Budget Officer, the City Auditor, the HRM Officer, with special copies to the Regional Director, Department of Budget & Management, Region 8, Tacloban City, the Regional Director Civil Service Commission, Region 8, Tacloban City and the Officer in Charge, Civil Service Commission (CSC) Field Office, this city and others concerned, -in Ormoc City;
