### PREFATORY STATEMENT

Section 13 Par. (b) of Republic Act 7160, otherwise known as the Local Government Code of 1991, in part provides:

- "(b) The Sanggunian of highly urbanized cities and component cities whose charters prohibit their voters from voting for provincial elective officials, hereinafter referred to in this Code as Independent Component Cities, may in consultation with Philippine Historical Commission, change the name of the following within its territorial jurisdiction: X X X
  - Public elementary, secondary and vocational or technical schools, community, colleges and non-chartered colleges."

It can be recalled that the Sangguniang Barangay of Brgy. San Jose, this city, the PTCA, Faculty Club and the Supreme Student Government of San Jose National High School have requested this Sanggunian to change the name of San Jose National High School to Genaro B. Lureñana Memorial National High School.

It is the consensus of this august Body that the will and desire of people of said locality be respected hence, this Sanggunian interposes no objection to the renaming of said school.

The National Historical Institute through a letter dated 21 November 2006 addressed to this sanggunian has this to say:

"We are pleased to inform you that the NHI interposes objection to the proposed renaming. However, it is suggested that the term "Memorial" be deleted for practical and aesthetic reasons and since it is understood that the honoree is already deceased. Moreover, it is recommended that the old name, which has been sanctified by usage by the residents of the community, be placed underneath the new name in the signage as follows:

# ORDINANCE NO. 131

AN ORDINANCE RENAMING SAN JOSE NATIONAL HIGH SCHOOL IN BARANGAY SAN JOSE, THIS CITY, TO GENARO B. LURENANA NATIONAL HIGH SCHOOL.

BE IT ORDAINED, by the 10th Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The San Jose National High School, located at Barangay San Jose, Ormoc City is now presently called as GENARO B. LURENANA NATIONAL HIGH SCHOOL.

SECTION 2. EFFECTIVITY. This Ordinance shall take effect after ten (10) days from its approval and after having published the same in full for a period of three (3) days in two (2) conspicuous and accessible places pursuant to the provisions of Section 188 of R.A. 7160.
