INTRODUCTORY STATEMENT

WHEREAS, in 2004, the 10th Sangguniang Panlungsod passed Ordinances No. 112 and 113, Series of 2004 (inadvertently incorporated as Chapters XII and XIII, Title Eleven (Transportation) which should have been incorporated under the Title on Traffic Regulation) declaring as one-way street, the following: (1) from the corner of Osmeña and J. Navarro Streets to the corner J. Navarro and Carlos Tan Streets; (2) from the corner of J. Navarro and Carlos Tan Streets to the corner of Carlos Tan and Arradaza Streets; (3) from the corner of Arradaza and Carlos Tan Streets to the corner of Arradaza and Osmeña Streets; (4) from the corner of Osmeña and San Pedro Streets to the corner of San Pedro and Carlos Tan Streets; (5) from the corner of Carlos Tan and San Pedro Streets to the corner of Carlos Tan and Arradaza Streets; and (6) from the corner of Arradaza and Carlos Tan Streets to the corner of Arradaza and Osmeña Streets, this city;

WHEREAS, the Barangay Council of Barangay District 10, after finding that the ordinances declaring as one-way traffic the subject streets, Arradaza street became a traffic "bottle neck" thus caused clogged traffic in the area because vehicles coming from Bonifacio Street cannot make a right turn to J. Navarro Street and likewise vehicles coming from Can-alo district cannot make a left turn to San Pedro Street, passed a resolution requesting the 10th Sangguniang Panlungsod to amend Ordinance Nos. 112 and 113, Series of 2004 by declaring as two-way traffic the following: (1) from the corner of J. Navarro and Osmeña Streets to the corner of J. Navarro and Carlos Tan Streets; and (2) from the corner of Osmeña and San Pedro Streets to the corner of San Pedro and Carlos Tan Streets;

Ordinance No. 132, series of 2007 amending Ordinances No. 112 and 113, Series of 2004 but which amendatory ordinance did not conform to the request of the Barangay Council of District X, this city, because aside from declaring as two-way streets, the following: (1) J. Navarro Street from the corner of Osmeña Street to Carlos Tan Street; and (2) San Pedro Street from the corner of Osmeña Street to the corner of Carlos Tan Street it also declared as two-way street Arradaza Street from the corner of Carlos Tan and Arradaza Streets to the corner of Arradaza and Osmeña Streets and, in addition, maintaining as one-way street Carlos Tan Street from the corner of San Pedro Street to the corner of J. Navarro Street;

WHEREAS, the aforesaid amendment further caused traffic chaos in the area hence, there is a need to repeal the above mentioned ordinances and new one to be enacted completely repealing Ordinances Nos. 112 and 113, series of 2004 and Ordinance No. 132, series of 2007;

WHEREFORE, on motion of Honorable Councilor Demosthenes F. Tagonon, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Rafael C. Omega, Jr. and Sotero M. Pepito; be it

RESOLVED, to enact:

ORDINANCE NO. 134

Series of 2007

(to be incorporated as CHAPTER XIV, TITLE ELEVEN
of the Code of General Ordinances)

AN ORDINANCE DECLARING AS TWO-WAY STREETS:

(1) J. NAVARRO STREET, this city, FROM THE CORNER OF J. NAVARRO AND OSMEÑA STREETS, TO THE CORNER OF J. NAVARRO AND CARLOS TAN STREETS; and

(2) SAN PEDRO STREET, this city, FROM THE CORNER OF SAN PEDRO AND OSMEÑA STREETS TO THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS; and

AND MAINTAINING AS ONE-WAY STREETS:

(1) CARLOS TAN STREET, this city, FROM THE CORNER OF CARLOS TAN AND J. NAVARRO STREETS TO THE CORNER OF CARLOS TAN AND ARRADAZA STREETS THEN FROM THE CORNER OF CARLOS TAN AND ARRADAZA STREETS TO THE CORNER OF ARRADAZA AND OSMEÑA STREETS; and,

(2) CARLOS TAN STREET, this city, FROM THE CORNER OF CARLOS TAN AND SAN PEDRO STREETS TO THE CORNER OF CARLOS TAN AND ARRADAZA STREETS THEN FROM THE CORNER OF CARLOS TAN AND ARRADAZA STREETS TO THE CORNER OF ARRADAZA AND OSMEÑA STREETS, THIS CITY.

THEREBY REPEALING (1) ORDINANCE NO. 112, SERIES OF 2004; (2) ORDINANCE NO. 113, SERIES OF 2004; INCORPORATED AS CHAPTERS XII AND XIII OF TITLE ELEVEN (TRANSPORTATION) OF THE CODE OF GENERAL ORDINANCES OF ORMOC CITY AND (3) ORDINANCE NO. 132 SERIES OF 2007.

AN ORDINANCE DECLARING AS TWO-WAY STREETS:

- (1) J. NAVARRO STREET FROM THE CORNER OF OSMEÑA AND J. NAVARRO STREETS TO THE CORNER OF J. NAVARRO AND CARLOS TAN STREETS, THIS CITY; AND
- (2) SAN PEDRO STREET FROM THE CORNER OF SAN PEDRO AND OSMEÑA STREETS TO THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS, THIS CITY;

AND MAINTAINING AS ONE-WAY STREETS;

- (1) CARLOS TAN STREET FROM THE CORNER OF J. NAVARRO AND CARLOS TAN STREETS TO THE CORNER OF CARLOS TAN AND ARRADAZA STREETS, THEN ARRADAZA STREET FROM THE CORNER OF CARLOS TAN AND ARRADAZA STREETS TO THE CORNER OF ARRADAZA AND OSMEÑA STREETS, THIS CITY; AND
- (2) CARLOS TAN STREET FROM THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS TO THE CORNER OF CARLOS TAN AND ARRADAZA STREETS, THEN ARRADAZA STREET FROM THE CORNER OF CARLOS TAN AND ARRADAZA STREETS TO THE CORNER OF ARRADAZA STREET AND OSMEÑA STREETS, THIS CITY;

THEREBY REPEALING ORDINANCE NOS. 112 AND 113, SERIES OF 2004 INCORPORATED AS CHAPTERS XII AND XIII OF TITLE ELEVEN (TRANSPORTATION) OF THE CODE OF GENERAL ORDINANCES OF ORMOG CITY AND ORDINANCE NO. 132, SERIES OF 2007;

BE IT ORDAINED, by the 11th Sangguniang Panlungsod, That:

SECTION 1. J. Navarro Street from the corner of Osmeña and J. Navarro Streets to the corner of J. Navarro and Carlos Tan Streets, this city, is hereby declared as two-way street.

SECTION 2. San Pedro Street from the corner of Osmeña and San Pedro Streets to the corner of San Pedro and Carlos Tan Streets, this city, is hereby declared as two-way street.

SECTION 3. Carlos Tan Street from the corner of J. Navarro and Carlos Tan Streets to the corner of Carlos Tan and Arradaza Streets then from the corner of Carlos Tan and Arradaza Streets to the corner of Arradaza and Osmeña Streets, this city, are hereby maintained as one-way streets.

SECTION 4. Carlos Tan Street from the corner of San Pedro and Carlos Tan Streets to the corner of Carlos Tan and Arradaza Streets then from the corner of Arradaza and Carlos Tan Streets, to the corner of Arradaza and Osmeña Streets, this city, are hereby maintained as one-way streets.

SECTION 5. Any violation of this ordinance shall be penalized with a fine of not less than Five Hundred (P500.00) Pesos or imprisonment of not less than ten (10) days but not more than thirty (30) days or both such fine and imprisonment at the discretion of the Court.

SECTION 6. Ordinances No. 112 and 113, Series of 2004 incorporated as Chapters XII and XIII of Title Eleven of the Code of General Ordinances of the City are hereby repealed and likewise, Ordinance No. 132, Series of 2007 is also hereby repealed.


SECTION 7. This ordinance shall be incorporated in the Code of General Ordinances as Chapter XIV Title Eleven (Traffic Regulation) of the Code of General Ordinances of the City of Ormoc.
