PREFATORY STATEMENT

WHEREAS, Sec. 17(b) of RA 7160 provides that Local Government Units must provide Health Care Services to its constituents;

WHEREAS, the Health Care Services in Ormoc City started as the City Health Dispensary where medicines and first aid treatment were available with only a handful of employees;

WHEREAS, the dispensary was later upgraded to the present City Health Office;

WHEREAS, Ormoc City is the most fast growing City in the Eastern Visayas with a population of over 200,000;

WHEREAS, the conditions and development of the City has made it imperative that the Health Services respond to the changing need of the times by decentralizing the management and operation of the City Health Office into six (6) District Health Centers located in strategic barangays with a full complement of physicians, nurses, midwives, Barangay Health Workers and Dentists for efficiency and good governance which is essential in the promotion of health and safety;

WHEREAS, the Ormoc City Health Office is recognized as one of the service Departments of the city under the direct management, supervision and control of the City Mayor;

WHEREFORE FOREGOING PREMISES CONSIDERED, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, jointly seconded by City Councilors Fernando P. Parrilla and Demosthenes F. Tugonon; be it

RESOLVED, to enact:

ORDINANCE NO. 135

AN ORDINANCE CHANGING THE NAME OF THE ORMOC CITY HEALTH OFFICE TO ORMOC CITY HEALTH DEPARTMENT.

SECTION 1. The name of Ormoc City Health Office will now be changed and hereinafter be called Ormoc City Health Department.

SECTION 2. This Ordinance shall take effect upon its approval.
