PREFATORY STATEMENT

This august Body is in receipt of an indorsement dated November 26, 2008 from the Hororable City Mayor Eric C. Codilla in connection with the proposed reduction of the present fare rates of Motorcabs/Tricycles-For-Hire following the successive roll backs of gasoline and oil prices. It is a fact that starting the last quarter of this year prices of gasoline and other petroleum products had considerably decreased which was immediately felt by the people.

Consequently, the general public clamors for a corresponding decrease of the present fare rates considering that the gasoline and oil prices have gope down. Grateful of the present situation and in response to the concern of the riding public, the Ormoc Motorized Tricycle For Hire Operators and Drivers Association (OMTODA) initiated a petition to reduce the present fare rates of motorcabs/ tricycles operating within the City of Ormoc.

In view thereof, a Public Hearing was conducted on December 12,2008 wherein it was unanimously agreed upon that an immediate roll back on the current fare rates of motorcabs-for-hire shall be done on the following manner:

> - 0.50 rollback Within the City Proper All Barangays within Ormoc City - 1.00 rollback

This sanggunian believes that the proposed fare reduction is proper and befitting to the present situation. Hence, there is a need to amend fare rates of Motorcabs/ Tricycles-For-Hire in Ormoc City as embodied in Ordinance No. 147 dated June 19, 2008.

ORDINANCE NO. 150

AN ORDINANCE REDUCING THE FARE RATES OF MOTORCABS/TRICYCLES-FOR-HIRE IN ORMOC CITY THEREBY AMENDING ORDINANCE NO. 147 DATED JUNE 19, 2008 OF THIS SANGGUNIAN.

BE IT ORDAINED, by the Eleventh Sangguniang Panlungsod ng Ormoc in regular session assembled, that:

SECTION 1. Article III- FARES under Ordinance No. 34 as amended by the latest Amendatory Ordinance No. 147 dated June 19, 2008 of the Sangguniang Panlungsod ng Ormoc is hereby amended to read as follows:

FARES:

The fare shall be established at a level that will provide the operator and driver a reasonable return of profit, and still be affordable to the general public.

Until such time that the Sangguniang Panlungsod ng Ormoc shall prescribe otherwise, the official fare rates shall be in accordance with the following schedule, to wit

The foregoing schedule of fare rates should be posted mandatorily in any part of the tricycle where said schedule can be easily seen by the passenger thereof. Failure to observe this requirement constitute a violation of this ordinance thereby making the operator and/ or the driver of the tricycle liable to the penalty provided for in Article VII- FinalProvisions, Section 2, Penal Provisions, Par. (b) of Ordinance No. 34. Furthermore, said schedule of fare rates shall be posted in three (3) conspicuous public places in the city and shall also be published once in a newspaper of general circulation in Ormac City;

SECTION 2. All other provisions of Ordinance No. 34, as amended, which are not affected by this latest amendment remains to be in full force and in effect.

SECTION 3. All Existing Ordinances, Executive Orders. Rules and Regulations inconsistent with this Ordinance are considered repealed or modified accordingly, as the case may be.

SECTION 4. This Ordinance shall take effect immediately after it shall have been published once in a local newspaper of general circulation within the City of Ormoc and posted in public places for at least (3) consecutive weeks.
