Codilla requesting for the approval of the proposed extension of the deadline for the payment of Real Property Taxes under the 2008 Tax Amnesty Program of the city to January 15,2009 in view of the numerous holidays during the month of December.

in Ordinance No. 146 of this sanggunian, As provided for in Ordinance No. 146 of this sanggunian, the duration of the 2008 Tax Amnesty Program will be until December 31, for 2008. However, due to the suspension of government transactions following the long holidays the chances of the interested taxpayers to avail of the program is also cut short.

Earlier the business community and the private sectors have also expressed their fears and apprehensions of being not able to beat the deadline mainly because of the present economic crisis and secondarily due to the prolonged holidays.

In consideration of the above concerns, this august Body feels that giving ample time to the taxpayers to settle their delinquent taxes is reasonable and appropriate to the present situation.

## ORDINANCE NO. 151

AN ORDINANCE APPROVING THE EXTENSION OF THE DEADLINE FOR THE PAYMENT OF REAL PROPERTY TAXES UNTIL JANUARY 15, 2009.

BE IT ORDAINED, by the Eleventh Sangguniang Panlungsod ng Ormoc in regular session assembled, that:

SECTION 1. The deadline for the payment of Real Property Taxes under the 2008 Tax Amnesty Program of Ormoc City is extended until January 15,2009.

SECTION 2. All existing Ordinances, Executive Orders, Rules and Regulations inconsistent with this Ordinance are considered repealed or modified accordingly, as the case may be.

SECTION 3. This ordinance shall take effect immediately upon its approval.

SECTION 4. For the purposes of complying with the provisions of Section 59 of RA 7160, otherwise known as the Local Government Code of 1991. A copy of this ordinance shall be posted in at least two (2) conspicuous places in the City Hall not later than five (5) days after approval and must be published once in a newspaper of general circulation within the City of Ormoc.
