PREFATORY STATEMENT

The City of Ormoc enacted Ordinance No. 27 Series of 1981 entitled: "AN ORDINANCE ESTABLISHING A TECHNOLOGICAL, MANPOWER TRAINING AND RESEARCH CENTER IN ORMOC CITY" on February 3, 1981 which shall be charged of maintaining a continuous study, research, development and evaluation of various subjects or courses geared towards general welfare of the people;

With the advent of modern technology, this august body finds it necessary to make some revisions of said ordinance to be able to meet the demands of modern times where training, modern methods and innovative techniques are needed to be globally competitive thus, empowering the modern Filipino worker;

WHEREFORE, FOREGOING PREMISES, on motion of the City Councilor Fernando P. Parrilla, Chairman, Committee on Manpower and Development, severally seconded by City Councilors Fe S. Lladoc, Jose C. Alfaro, Jr. and Rafael C. Omega, Jr.; be it

RESOLVED, to enact:

ORDINANCE NO. 155

AN ORDINANCE REVISING S.P. ORDINANCE NO. 27 SERIES OF 1981, ENTITLED: ESTABLISHING A TECHNOLOGICAL MANPOWER TRAINING AND RESEARCH CENTER IN ORMOC CITY.

BE IT ENACTED, by the Eleventh Sangguniang Panlungsod ng Ormoc,  
That:

SECTION 1. TITLE - THIS ORDINANCE SHALL BE KNOWN AND CITED AS "THE REVISED ORDINANCE ESTABLISHING THE TECHNOLOGICAL, MANPOWER TRAINING AND RESEARCH CENTER IN ORMOC CITY."

SECTION 2. THE CENTER - There shall be established in the City of Ormoc a Center to be known as the "Ormoc City Technological, Manpower Training and Research Center" which shall undertake the following functions and objectives:

- a. Conducts a continuous study, research, training development and evaluation of various courses and seminars by tapping governmental agencies and private sectors that are involved in socio-economic development programs geared to uplift the general welfare of the people;
- b. Serves as the Center for manpower trainers, technologists, and other specialists dealing with socio-economic development;
- c. Conducts non-formal education trainings, seminars, workshops, short-term vocational and technological courses on any aspect of human endeavor in general and manpower development in particular;
- d. Adopts a continuing manpower development program on modern technology to update knowledge and skills;
- e. Serves as the Center for all phases of modern development and all research activities; and
- f. Aims and strives to be self-sustaining in its operation.

SECTION 3. BOARD OF TRUSTEES - The Board of Trustees shall be the policy making body of the Center which shall be composed of the following:

Member	-	DepEd ES1 - ALS Representative
Member	-	President, LIGA ng mga Barangay
Member	-	Center Administrator

SECTION 4. POWERS OF THE BOARD OF TRUSTEES - The Board of Trustees as a policy making body shall have the following powers and duties:

- a. Appoints Center Administrator with a term of three (3) years without prejudice to reappointment, who may be removed from the service for loss of confidence by two-third (2/3) votes of all members of the Board of Trustees;
- b. Administers, manages, controls and supervises the activities provided for in Section 2 hereof;
- c. Prescribes rules and regulations to carry out the purposes for which the Center is established;
- d. Determines the number of staff and personnel needed in the operation of the Center, including their remuneration in accordance with the human resource development thrusts of Ormoc City;

- e. Receives donations and grants of all kinds and appropriates the same for the purpose specified by law or by the donor;
- f. Administers its funds and disburses the same subject to government accounting rules and regulations;
- g. Procures such facilities, tools and other equipment necessary for the Center;
- h. Approves curricular or training requirement necessary for the Center;
- i. Prescribes training and other fees and ensure its remittance to the City Treasurer's Office;
- j. Authorizes the Chairman of the Board of Trustees to confirm all candidates for graduation.

SECTION 5. THE PHYSICAL SET-UP - There shall be a suitable building on a government lot where this Center shall be housed which shall have adequate spaces for seminar rooms, training bays, workshops, and audio-visual rooms. It shall also provide office spaces and restrooms for staff and students and such other facilities that are needed to carry out the objectives of the Center, and that funds for the construction of the physical plant shall be derived from such sources as the Board of Trustees may deem proper and convenient.

SECTION 6. FUNDING - The operation of the Center shall be funded from such sources as donations, grants in aid, and such other moneys obtained from various sources by the Center both from government and private agencies.

- a. The City Government of Ormoc shall appropriate funds needed to carry out the objectives and purposes of the Center upon recommendation of the Board of Trustees;
- b. All accounts and expenses therefor shall be audited by the Commission on Audit and all disbursements shall be made in accordance with auditing rules and procedures;

SECTION 7. REPEAL - This ordinance repeals SP Ordinance No. 27 Series of 1981 and all other ordinances inconsistent herewith.


SECTION 8. EFFECTIVITY - This ordinance shall take effect after it shall have been published once in a local news paper of general circulation within the City of Ormoc, and posted in at least four (4) conspicuous and publicly accessible places.
