PREFATORY STATEMENT

The Eleventh Sangguniang Panlungsod ng Ormoc has received an indorsement from the Office of the City Mayor relative to the communications coming from the Ormoc Motorized Tricycles for Hire Operators and Drivers Assocation (OMTODA) dated January 13, 2010 and January 28, 2010. The subject thereof, is the appeal of the Officers and Members of the aforementioned association for an increase of the minimum fare of tricycles for hire within the City of Ormoc which was proposed to be at PO.50 within the City Proper and P1.00 for all Barangays within the city.

The request was anchored on the fact that the prices of gasoline and other petroleum products have considerably increased for the past months. Data showed that in the last quarter of 2008 the premium gasoline being used by tricycles only costs P34.00/ liter more or less. Since then, its price tremendously went up bringing it to the current price of almost P50.00/liter. Adding to the dilemma, is the high cost of spare parts necessary to keep the vehicle in good running condition. These facts render the daily income of both tricycle drivers and operators much lesser and insufficient to make both ends meet considering the high prices of prime commodities nowadays. Thus, it is believed that the approval of the requested fare increase is beneficial and will strengthen the purchasing power of the drivers and operators.

In order to determine the fairness of the proposed minimum fare increase as initiated by the members of OMTODA, a Public Hearing was conducted on March 3, 2010 at the Sangguniang Panlungsod Session Hall. In the presence of concerned authorities, the matter was thoroughly discussed taking into consideration the pros and cons of the issue. The consultation yielded favorable results and the proposal to impose a PO.50 increase on the minimum fare within the city proper and P1.00 increase in all barangays within Ormoc City, received positive response from the public.

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Jose C. Alfaro, Jr, Vice-Chairman, Committee on Communications and Transportation, jointly seconded by City Councilors Mariano Y. Corro and Fernando P. Parrilla; be it

RESOLVED, to enact:

ORDINANCE NO. 160

AN ORDINANCE ESTABLISHING THE 2010 FARE RATES FOR TRICYCLES-FOR-HIRE IN ORMOC CITY THEREBY AMENDING FURTHER ORDINANCE NO. 34 ARTICLE 3, THEREOF.

BE IT ORDAINED, by the Eleventh Sangguniang Panglunsod ng Ormoc in regular session assembled, that:

SECTION 1. Article III- FARES under Ordinance No. 34, as amended by the latest Amendatory Ordinance No. 150 dated December 18, 2008 of the Sangguniang Panlungsod ng Ormoc is hereby further amended to read as follows:

FARES:

The fare shall be established at a level that will provide the operator and the driver a reasonable return of profit, and still be affordable to the general public.

Until such time that the Sangguniang Panlungsod ng Ormoc shall prescribe otherwise, the official fare rates shall be in accordance with the following schedule, to wit:

The foregoing scendule of fare rates should be posted mandatorily in any part of the tricycle where said schedule can be easily seen by the passenger thereof. Failure to observe this requirement constitute a violation of this ordinance thereby making the operator and/ or the driver of the tricycle liable to the penalty provided for in Article VII- Final Provisions, Section 2, Penal Provisions, Par. (b) of Ordinance No. 34. Furthermore, said schedule of fare rates shall be posted in three (3) conspicuous public places in the city and shall also be published once in a newspaper of general circulation in Ormoc City;

SECTION 2. All other provisions of Ordinance No. 34, as amended, which are not affected by this latest amendment remains to be in full force and in effect.

SECTION 3. All exisiting Ordinances, Executive Orders, Rules and Regulations inconsistent with this Ordinance are considered repealed or modified accordingly, as the case may be.

SECTION 4. This Ordinance shall take effect immediately after it shall have been published once in a local newspaper of general circulation within the City of Ormoc and posted in public places for at least three (3) consecutive weeks.

ENACTED, March 18, 2010.

RESOLVED, further, to furnish copies of this ordinance each to the Honorable City Mayor Eric C. Codilla; the City administrator; the City Legal Officer; the Permits, Licenses and Franchising Division; the City Director, PNP; the Precinct Commander, PP1; the ABC President; the City Director, DILG; the Barangay Affairs Office; the President, OMTODA; and others concerned, all in Ormoc City.
