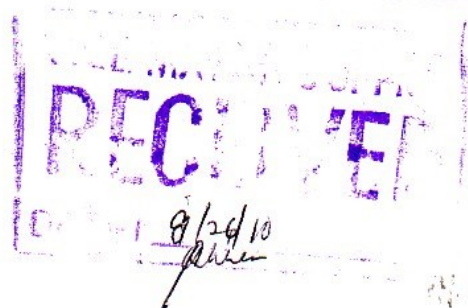

PREFATORY STATEMENT

WHEREAS, the Local Government Code or Republic Act No. 7160 granted every Local Government Unit the autonomous power to formulate ordinances, resolutions, and regulations necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare.

WHEREAS, this August Body is in receipt of the 2<sup>nd</sup> Indorsement dated March 9, 2010 from the Office of the City Mayor on the matter of the preceding indorsement from the Human Resources Management Division for the proposed re-allocation of Forty-Three (43) positions with the corresponding salary adjustments to be charged against CY 2010 Personal Services Savings from vacant positions in the City Health Department and the City Library;

WHEREAS, the request finds basis on Local Budget Circular No. 2009-92 dated September 3, 2009 which implemented the First Tranche Monthly Salary Schedule of Local Government Personnel and the Modified Position Classification System, as supplemented by Local Budget Circular No. 2009-92A dated December 17, 2009 which provides the Rules and Regulations on the Salary Adjustments of the Public Health Workers (PHWs) to supplement Local Budget Circular No. 2009-92.



WHEREAS, in order to initially carry out the said staffing modification and salary adjustments, the city legislature deems it appropriate to enact a measure which will involve the effective implementation in accordance with the pertinent provisions of the Local Government Code or RA No.7160, existing budgeting and Civil Service Laws, rules and regulations to include the above-mentioned Local Budget Circulars.

WHEREAS, the projected cost of the proposed re-allocation of positions is ONE MILLION NINE HUNDRED FOURTEEN THOUSAND FOUR HUNDRED EIGHTY-NINE PESOS & 76/100 (P 1,914,489.76).

FOREGOING PREMISES, CONSIDERED, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Good Government, jointly seconded by City Councilors Rafael C. Omega, Jr. and Lea Doris C. Villar; be it

RESOLVED, to enact:

ORDINANCE NO. 162

AN ORDINANCE RE-ALLOCATING A TOTAL OF FORTY-THREE (43) POSITIONS UNDER THE CITY HEALTH DEPARTMENT AND THE CITY LIBRARY PURSUANT TO LOCAL BUDGET CIRCULAR NO. 2009-92 DATED SEPTEMBER 3, 2009 AS SUPPLEMENTED BY LOCAL BUDGET CIRCULAR NO. 2009-92A DATED DECEMBER 17, 2009 AND APPROPRIATING THE SUM OF ONE MILLION NINE HUNDRED FOURTEEN THOUSAND FOUR HUNDRED EIGHTY-NINE PESOS & 76/100 (P 1,914,489.76).

BE IT ORDAINED, BY THE Sangguniang Panlungsod of Ormoc City in session assembled, that:

SECTION 1. TITLE – This ordinance be known and referred as “ORDINANCE RE-ALLOCATING A TOTAL OF FORTY-THREE (43) POSITIONS UNDER THE CITY HEALTH DEPARTMENT AND THE CITY LIBRARY PURSUANT TO LOCAL BUDGET CIRCULAR NO. 2009-92 DATED SEPTEMBER 3, 2009 AS SUPPLEMENTED BY LOCAL BUDGET CIRCULAR NO. 2009-92A DATED DECEMBER 17, 2009 AND APPROPRIATING THE SUM OF ONE MILLION NINE HUNDRED FOURTEEN THOUSAND FOUR HUNDRED EIGHTY-NINE PESOS & 76/100 (P 1,914,489.76).”

SECTION 3. APPROPRIATION- The amount of ONE MILLION NINE HUNDRED FOURTEEN THOUSAND FOUR HUNDRED EIGHTY-NINE PESOS & 76/100 (P 1,914,489.76) represents cost of the Re-allocated Classes of Positions per LBC No. 2009-92 as supplemented by LBC No. 2009-92A to be charged against CY 2010 Personal Services Savings from vacant positions in the City Health Department and the City Library and shall be appropriated for the implementation of this ordinance.


SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately after the compliance of the necessary posting requirements as provided for in the Local Government Code of 1991.
