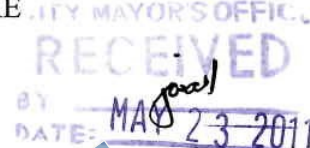

PREFATORY STATEMENT

WHEREAS, the hanging of streamers in the streets and roads within the City of Ormoc was controlled and regulated by virtue of Ordinance No. 87 dated February 14, 2002, entitled: AN ORDINANCE REGULATING THE HANGING OF STREAMER/S IN THE STREETS AND ROADS WITHIN THE CITY OF ORMOC PROVIDING FEES AND IMPOSING PENALTY FOR VIOLATION THEREOF, THEREBY AMENDING SECTION 1(E) OF ORDINANCE 42, ENTITLED: "AN ORDINANCE ESTABLISHING CODE OF PUBLIC SAFETY DURING FESTIVITIES AND CELEBRATIONS".

WHEREAS, in view of this year's fiesta celebration of the City of Ormoc, this august Body believes that it is reasonable that the existing city regulations on the hanging of streamers shall be temporarily suspended to give chance to prospective advertisers to put up their respective streamer/s in various strategic locations within the City of Ormoc during the fiesta season provided that public safety shall be given due consideration;

WHEREAS, in line with the temporary suspension of the provisions of Ordinance No. 87, the 2011 Ormoc City Fiesta Executive Committee shall take charge on the aspects concerning the hanging of streamers in the city streets to ensure that there is public order and safety;

WHEREAS, the temporary suspension of the regulations on the hanging of streamers shall cover the period May 20, 2011 until July 15, 2011, after which the provisions of Ordinance No. 87 shall be duly enforced;

FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Ruben R. Capahi, Majority Floor Leader, jointly seconded by City Councilors Rafael C. Omega, Jr. and Antonio M. Codilla; be it

RESOLVED, to pass and enact:

ORDINANCE NO. 167

AN ORDINANCE TEMPORARILY SUSPENDING THE REGULATIONS ON THE HANGING OF STREAMERS IN THE CITY STREETS WITHIN THE CITY OF ORMOC AS EMBODIED IN ORDINANCE NO. 87 DATED FEBRUARY 14, 2002 TO GIVE WAY TO VARIOUS ADVERTISEMENTS IN RELATION TO THE FORTHCOMING 2011 ORMOC CITY FIESTA CELEBRATION.

BE IT ORDAINED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION I. The temporary suspension of the regulations on the hanging of streamers in the city streets within the City of Ormoc shall cover the period May 20, 2011 until July 15, 2011 only, after which the provisions of Ordinance No. 87 shall be duly enforced.


SECTION 2. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
