PREFATORY STATEMENT

WHEREAS, the 12 Sangguniang Panlungsod ng Ormoc received an indorsement dated May 31, 2012 from the Office of the City Mayor relative to the proposed creation of new regular positions under the Ornice Waterworks Division as requested by Engr. Gervacio L. Germano, Ir., Waterworks Superintendent II.

WHEREAS, the request for the creation of new regular positions is deemed necessary to complement the manpower requirement of the said office considering the increase in the coverage area and the increasing number of water connections presently served and managed by the Ormoc Waterworks Division following the Improvement and Expansion of the Ormoc City Water Supply System. Hence, the positions that shall be created are vital to ORWASA's effective and efficient public service.

WHEREAS, the Sangguniang Panlungsod, as the Legislative Body of the city, has the responsibility to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city (Sec. 458, Local Government Code of 1991). Furthermore, the LGC provides that the Sangguniang Panlungsod shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government (Sec. 458 (1) (viii) of LGC of 1991).

WHEREAS, on account of the pressing need to create the positions requested by Engr. Germano at the Ormoc Waterworks Division for the betterment of public service to Ormocanons, and also taking into consideration the financial capability of the city to fund the related expenses in relation thereto, this august Body resolves to pass a legislative measure for the creation of new regular positions under the Ormoc Waterworks Division.
