EXPLANATORY NOTE

TUGOB is a Visayan word that means bountiful or abundant.

The TUGOB Festival is not akin to other festivities in any part of the regions in the Philippines considering that TUGOB is a festivity held to draw attention not only to Ormocanons but of other Cities and Municipalities throughout the country, that Ormoc has its own way of highlighting a commemoration of its Charter Day otherwise known as "ADLAW SA ORMOC".

The TUGOB restival aims to showcase the twelve (12) products/resources identified to have contributed to the development of the City, namely: flower, steam, water, pineapple, sugarcane, root crops, fish, livestock, coconut, vegetables, rice and even sand and gravel. To translate these products, which are abundant in the City, into a festival, different business establishments, schools and colleges of the City were tapped to depict it. The highlights of the event are the Search for Ms. TUGOB FESTIVAL QUEEN, the TUGOB FESTIVAL STREET DANCING and the TUGOB FESTIVAL DANCE COMPETITION.

The TUGOB FESTIVAL has been celebrated for the past two (2) years' Charter Day Anniversary and has created the impression that Tugob Festival is identified with Ormoc City and Ormoc City with Tugob Festival.

It is the expectation of this august body that the enactment of this Ordinance will enhance and support the tourism goals of the City of Ormoc, after all, our Local Government Code of 1991, in its provisions of Basic Services and Facilities (Section 17 thereof) include "TOURISM AND CULTURE AND THE ARTS DEVELOPMENT" as part of the basic services that the City is mandated to perform.

WHEREFORE, foregoing premises considered, on motion of City Councilor Filomeno P. Maglasang, Chairman, Committee on Education, Culture and the Arts, severally seconded by City Councilors Sotero M. Pepito, Ruben R. Capahi, Lea Doris C. Villar and Corinne M. Corro; be it

RESOLVED, as it is hereby resolved, to enact:

ORDINANCE NO. 174

AN ORDINANCE INSTITUTIONALIZING THE TUGOB FESTIVAL AND FIXING THE DATE AND FUNDING THEREOF.

BE IT ENACTED BY THE 12TH Sangguniang Panlungsod ng Ormoc, That-

SECTION 1. This Ordinance shall be known and cited as the "TUGOB FESTIVAL ORDINANCE OF ORMOC CITY".

SECTION 2. That this Ordinance is enacted so as to promote and preserve the TUGOB FESTIVAL which will showcase the products/resources which are abundant in Ormoc City, and as a manifestation of thanksgiving to the ALMIGHTY GOD for the graces and blessings he has bestowed to Ormoc City inhabitants and finally to boost and promote tourism, culture and the arts which will bring incalculable economic benefits for Ormocanons and the City as a whole.

SECTION 3. That the TUGOB FESTIVAL shall be held every 20th day of October as part of the "Adlaw ng Ormoc" (City Charter Day) activities

SECTION 4. That the activities of the TUGOB RESTIVAL shall be handled by a Tugob Festival Committee to be created through an EXECUTIVE ORDER issued by the City Mayor defining the functions of the committee and other relevant matters appertaining thereto, to be composed of the following:

- (1) Heads of the stakeholders representing the twelve (12) products/resources;
- (2) President, Liga ng mga Barangay of Ormoc City;
- (3) President, Savggunian Kabataan Federation of Ormoc City;
- (4) President, City of Ormoc Government Employees Association;
- (5) Division Superintendent, Department of Education, Ormoc City Division;
- (6) Ormoc City General Services Officer;
- (7) Ormoc City Engineer;
- (8) Ormoc City Planning & Development Officer;
- (9) Representative of the Ormoc City Tourism Council;
- (10) Ornoc City Tourism Officer;
- (11) Representative of the Ormoc City Culture & the Arts Council;
- (12) Eight (8) Representatives coming from each Civic Clubs, Professional Organization and other organizations;

The creation of the aforementioned committee shall be done within seven (7) days from the passage of this Ordinance.

SECTION 5. That an initial funding in the amount of ONE MILLION PESOS (P1,000,000.00) to defray expenses necessary for or incidental to the conduct and operation of the TUGOB FESTIVAL. Thereafter, the City Government shall provide an annual appropriation of P1,000,000.00 as aid to the Tugob Festival.

That in addition thereto, the funding for the conduct of the activities of the TUGOB FESTIVAL shall come from, but not limited to, SOLICITATION, DONATION, FINANCIAL ASSISTANCE FROM THE CITY GOVERNMENT OF ORMOC, and money generated from related activities during the FESTIVAL.

SECTION 6. That the Executive Committee Members may form from among themselves a non-stock corporation or a foundation in order to have a juridical and/or legal personality and henceforth, the activities of the TUGOB FESTIVAL shall be handled by the TUGOB FESTIVAL FOUNDATION.

SECTION 7 That any Ordinance, resolution or parts thereof not consistent herewith are hereby repealed, amended or superseded, accordingly.

SECTION 8. That, if for any reason, any portion of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity of the other provisions not affected thereby.

SECTION 9. This Ordinance shall take effect immediately after its posting and publication as required by the Local Government Code, are complied with.
