Prefatory Statement

Section 76 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that 'every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission'

WHEREAS, the Sangguniang Panlungsod, as the Legislative Body of the city, is empowered to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city x x x (Sec. 458, LGC of 1991). Furthermore, the Code provides that the Sangguniang Panlungsod shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government (Sec. 458 (1) (viii) of LGC of 1991).

WHEREAS, in line with the said provisions of the law, the Honorable City Mayor Eric C. Codilla through an Indorsement dated December 14, 2012, has requested this august Body for the creation of Four (4) new regular positions of City Government Assistant Department Head I, SG-23 at the following key offices under the Office of the City Mayor, to wit: Business Permits, Licensing and Franchising Office, Public Affairs , Information and Assistance Division, Environment and Natural Resources Division, and Internal Audit Services Division.

WHEREAS, the aforementioned Offices are among the key offices of the Local Government Unit of Ormoc City which performance have contributed much in the promotion of good governance and competitiveness of LGU-Ormoc. They also play a key role towards achieving the millennium goals and a self-sustaining local autonomy. The request for these

positions to be created is indeed reasonable considering the complex functions and obligations attached to the said offices. Thus, the proposed creation of positions which will eventually head the offices concerned (the positions are classified as higher than a Division Chief but lower than a Department Head), is anticipated to further boost the office performance and productivity.

WHEREAS, taking into consideration the financial capability of the city to fund the related expenses in relation thereto, this august Body believes that there is merit to the proposed creation, the purpose of which is geared towards the betterment of public service to the Ormocanons.

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Ruben R. Capahi, Chairman, Committee on Good Government, jointly seconded by City Councilors Lea Doris C. Villar and Sotero M. Pepito; be it

RESOLVED, to enact:

ORDINANCE NO. 178

AN ORDINANCE CREATING FOUR (4) NEW REGULAR POSITIONS OF CITY GOVERNMENT ASSISTANT DEPARTMENT HEAD I – SG 23 AT THE FOLLOWING OFFICES UNDER THE OFFICE OF THE CITY MAYOR, TO WIT:

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION I. There shall be created Four (4) new regular positions of City Government Assistant Department Head I, SG-23 at the following offices under the Office of the City Mayor, to wit:

The newly created positions are deemed necessary for the better, more effective and efficient operation of the concerned offices.

SECTION 2. The appropriation necessary to cover the cost of the newly created positions shall be sourced from city funds that shall be certified as available by the City Budget Officer and the City Treasurer subject however, to the 55% PS Limitations as provided for in the Local Government Code of 1991.

SECTION 3. Should any part or provision of this Ordinance be held unconstitutional and declared invalid by competent court, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 4. All Ordinances or Executive Orders or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 5. This Ordinance shall take effect immediately after the compliance of the necessary posting and publication requirements as provided for in the Local Government Code of 1991.

ENACTED, JANUARY 31, 2013.

RESOLVED, FURTHER, to furnish copies of this ordinance each to the Honorable City Mayor Eric C. Codilla; the City Administrator; the City Budget Officer; the City Accountant; the City Treasurer; the Human Resource Management Office; the City Auditor; the Regional Director, Civil Service Commission, Regional Office No. 8 thru the Civil Service Commission Field Office, Ormoc City; and other offices concerned.
