## PREFATORY STATEMENT

WITCREAS, the Twelfth Sanggusiang Panlungsod ng Ormoc received a request from the Honorable City Mayor Pric C. Codilla per his 1<sup>st</sup> Indorsement dated January 14, 2013, for the creation of Four (4) new regular positions of City Government Assistant Department I, SG-23 at the following offices under the City Administrator's Office, to wit: Human Resource Management Office, Ormoc City Waterworks Office, Ormoc City Superdome Office, and Ormoc City Public Market Office. The request was made following the creation of the same position in Four (4) key offices under the Office of the City Mayor.

WHEREAS, these Four(4) offices under the City Administrator's Office are among the key offices of the Local Government Unit of Ormoc City. Just like the other offices for which the position of City Government Assistant Department Head-I were earlier created, they also play a key role towards achieving the millennium goals and a self-sustaining local autonomy and shared the same goals and vision for a better and efficient public service to Ormocanons.

WHEREAS, the request for these positions to be created is reasonable considering the functions and obligations attached to the said offices. Thus, the proposed creation of positions which will eventually head the offices concerned (the positions are classified as higher than a Division Chief but lower than a Department Head), is anticipated to further boost the office performance and productivity.

WHEREAS, the Local Government Code of 1991, specifically Section 76 thereof provides that "every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";

WHEREAS, the Sangguniang Panlungsod, as the Legislative Body of the city, is empowered to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city x x x (Sec. 458, LGC of 1991). Furthermore, the Code provides that the Sangguniang Panlungsod shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government (Sec. 458 (1) (viii) of LGC of 1991).

WHEREAS, taking into consideration the financial capability of the city to fund the related expenses in relation to the proposed creation, this august Body believes that the request of the Honorable City Mayor is meritorious and deserving of immediate legislative action.

WHEREFORE, FOREGOING PREMISES CONSIDERED, or motion presented by City Councilor Ruben R. Capahi, Chairman, Committee on Good Government, jointly seconded by City Councilors Lea Doris C. Villar and Jose C. Alfaro, Jr.; be it

# ORDINANCE NO. 180

AN ORDINANCE CREATING FOUR (4) NEW REGULAR POSITIONS OF CITY GOVERNMENT ASSISTANT DEPARTMENT HEAD I – SG 23 AT THE FOLLOWING OFFICES UNDER THE CITY ADMINISTRATOR'S OFFICE, TO WIT:

SECTION I. There shall be created Four (4) new regular positions of City Government Assistant Department Head I, SG-23 at the following offices under the City Administrator's Office, to wit:

The newly created positions are deemed necessary for the better, more effective and efficient operation of the concerned offices.

SECTION 2. The appropriation necessary to cover the cost of the newly created positions shall be sourced from city funds that shall be certified as available by the City Budget Officer and the City Treasurer subject however, to the 55% PS Limitations as provided for in the Local Government Code of 1991.

SECTION 3. Should any part or provision of this Ordinance be held unconstitutional and declared invalid by competent court, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 4. All Ordinances or Executive Orders or any parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 5. This Ordinance shall take effect immediately after the compliance of the necessary posting and publication requirements as provided for in the Local Government Code of 1991.
