PREFATORY STATEMENT

WHEREAS, the 12th Sangguniang Parlangsod ng Ormoc received an Indorsement dated April 4, 2013 from the Office of the City Mayor in connection with the letter of Mr. Richard I. Gomez, City Chairman, Liberal Party (LP), requesting for the issuance of a permit for the use of a portion of Axiles Street, particularly the whole length adjacent to Ormoc Centrum on May 11, 2013 in line with the political cally of LP candidates on the said date;

WHEREAS, in view thereof, the temporary closure of the said portion of Aviles Street, identified as from the corner of Aviles - Malacadios Streets to the corner of Aviles - San Pedro Streets on May 11, 2013 from 1:00 o'clock in the afternoon to 11:30 in the evening is further sought to accommodate the said political activity of the LP candidates and likewise, to ensure the protection and safety of the riding public;

WHEREAS, the Local Government Code of 1991 specifically Section 21 thereof, empower the LGUs to temporarily close or open any road, alley, park or square within its territorial jurisdiction through an ordinance;

WHEREAS, Section 21, Par. (a) and (c) of the Code provides that:

Sec. 21- Closure and Opening of Roads –

- A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, x x x falling within its X X X
- (c) national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, the duration of which shall be specified by the Local Chief Executive concerned through a written order:

WHEREAS, this august Body believes that the request is lawful and deserving of appropriate action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Demosthenes F. Tugonon, Chairman, Committee on Public Properties, duly seconded by City Councilor Jose C. Alfaro, Jr.; be it

RESOLVED, to enact:

ORDINANCE NO. 183

AN ORDINANCE TEMPORARILY CLOSING A PORTION OF AVILES STREET FROM THE CORNER OF AVILES - MALACADIOS STREETS TO THE CORNER OF AVILES - SAN PEDRO STREETS ON MAY 11, 2013 FROM 1:00 O'CLOCK IN THE AFTERNOON TO 11:30 IN THE EVENING ONLY WITHOUT PREJUDICE AND SUBJECT TO WHATEVER REGULATION AND GUIDELINES THE LOCAL COMELEC WILL PROVIDE RELATIVE TO PUBLIC SAFETY.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION I. The portion of Aviles Street particularly from the corner of Aviles - Malacadios Streets to the corner of Aviles - San Pedro Streets shall be temporarily closed on May 11, 2013 from 1:00 o'clock in the afternoon to 11:30 in the evening to be utilized as venue of the political rally of LP candidates to be conducted on said date.

SECTION 2. The said temporary closure shall be strictly imposed on the said area on the date specified. In effect thereof, all public and private vehicles will be prohibited to enter or pass on the affected premises.

SECTION 3. This Ordinance shall take effect immediately subject to the compliance of the necessary posting and publication requirements as provided for in the Local Government Code of 1991.

ENACTED, April 25, 2013.

MESOLVED, FURTHER, to furnish copies of this ordinance each to the Honorable City Mayor Eric C. Codilla; the City Administrator; the City Legal Officer; the City Planning & Development Office; the City Director, Ormoc City Police Office; Mr. Richard I. Gomez, LP City Chairman, Ormoc City Chapter; and other offices concerned.
